Fiscal Year (FY) 2026 Special Education Grant Assurances Due Tuesday, July 1 FY 2026 Individuals with Disabilities Education Act (IDEA) Part B Grant Assurances templates and instructions for using the Grant Management System are now available for completion and can be found here: Moodle>Fiscal>Part B Grants for Special Education>FY26 Grant Information>Assurances. To reserve the earliest reimbursement effective date for the FY 2026 Part B grant period, public school corporations, charter schools, and state schools must submit correctly completed Assurances for the FY 2026 Part B grants in the Grant Management System on or before Tuesday, July 1, 2025. Please contact partbgrants@doe.in.gov with any questions. 2026 General Education Provision Act (GEPA) Forms Due Tuesday, July 1 To comply with Section 427 of GEPA, local educational agencies (LEAs) requesting IDEA Part B funds must have an approved GEPA

statement of compliance on file. If an LEA needs to update its GEPA section 427 form, a new form will need to be completed and uploaded to the IDOE's grant management system. The GEPA form can be found in Moodle>Fiscal>Part B Grants for Special Education>FY26 Grant Information>GEPA Section 427. All questions must be answered on the GEPA form. Special Education Excess Cost (SEEC) - New Minimum Amount LEAs Required to Pay Per Indiana Code 20-35-6-2, corporations are required to pay their share of expenditures before the state will fund excess costs. Any SEEC application submitted starting July 1, will be required to pay at minimum \$30,621.63, which is applied per Individualized Education Program (IEP). This amount is calculated using three times the current state average per pupil amount of \$10,207.21. Contact Sarah Fields with any questions. Encumber All FY 2024 Part B Grant Funds by Tuesday, September 30 To ensure sufficient time for budget modification review and approval, submit all FY 2024 IDEA Part B grant budget modification requests by Monday, September 15. All FY 2024 Part B funds must be encumbered by Tuesday, September 30. The FY 2024 Part B grant reimbursement requests must be submitted to specialedpartb@doe.in.gov by Monday, December 15. The form to request the FY 2024 Part B Grant Proportionate Share Release will be available starting Tuesday, July 1. The due date for the next round of Part B monitoring reports is Thursday, July 31. All Part B grant forms and related guidance are available under Part B Grants for Special Education in the Office of Special Education Moodle Community's Fiscal section. IDEA Part B Reimbursement Requests

2024-2025 Paraprofessional Training Grant Reimbursement Requests The 2024-2025 Paraprofessional Training Grant will close on Monday, June 30. The Office of Special Education requests that expense reimbursements are submitted by Monday, June 30, 2025. Reimbursement requests should be submitted by email to para@doe.in.gov with "FY24-25 Para Grant Reimbursement" in the subject line. IDOE's Office of Special Education has implemented a new fiscal monitoring for Part B funds. Reimbursement requests must be submitted within one month of incurring expenses on the 1st or 15th of the month. Corporations, cooperatives, and inter-locals cannot keep reimbursement requests open until the end of the award period. If your school corporation is not current with your IDEA Part B reimbursements, we request that you submit expense reimbursements through May 31, 2025, by June 30, 2025. Submit the form by email to specialedpartb@doe.in.gov with "FY2024 or FY2025 reimbursement form" in the subject line.

All Individuals with Disabilities Education Act (IDEA) Part B Reimbursements IDOE is currently compiling data for the Annual Comprehensive Financial Report (ACFR), which includes all IDEA Part B expenses. Schools must submit individual requests through June 30, 2025, and for July 1, 2025. Schools must submit separate reimbursement requests for June and July to specialedpartb@doe.in.gov to avoid potential delay with your payment. FY 2024 Part B Grant Proportionate Share Release Request Forms Will Be Available Tuesday, July 1 The FY 2024 Part B 611 and 619 grant proportionate share release forms will be available on Tuesday, July 1, in the Office of Special Education Moodle Community. Completed requests with supporting documentation must be submitted to IDOE's Office of Special Education Part B Grants team by Friday, August 29. Following the acceptance of the release form, a Part B grant budget modification request must be completed by Monday, September 15, to transfer funds across budget scopes. 2025-2026 School Year RoboKind Grant Opportunity Through House Enrolled Act 1001 (2025), IDOE offers the RoboKind Grant opportunity for select corporations and schools to purchase robotic technology and provide professional development endorsed by the Council for Administrators of Special Education (CASE) to improve the social and behavioral skills of students with autism. RoboKind's programs are delivered by engaging virtual avatars. While the programs no longer require a physical robot, districts currently implementing the robot-led program may continue using their robots if they apply for a renewal. Existing partner districts will also receive access to the virtual avatar-led programs, in addition to their current robotled implementations. IndianaMAC Participation Agreements—Coming Soon For your school corporation to continue participating in the Indiana School-Based Medicaid Administrative Claiming Program (IndianaMAC), the corporation superintendent must sign a new Participant Agreement (PA) with the new IndianaMAC vendor, Fairbanks LLC, before September 1, 2025. The new PA mirrors the previous vendor's agreement. In the coming days, school corporation superintendents will receive an email from FAIRBANKSLLC via Adobe Acrobat Sign (sent from adobesign@adobesign.com). This email will contain a PDF version of the Participant Agreement, which can be signed electronically and returned immediately to Fairbanks LLC. The Office of Special Education has renewed its Memorandum of Understanding with the Family and Social Services Administration's Bureau of Child Development Services (First Steps) effective June 30, 2025, to June 30, 2027. The field should review the following change to the Memorandum of Understanding regarding LEA responsibilities for the transition conference and the role of parental consent for the meeting: Former: "With parental consent, the LEA agrees to be contacted by the service coordinator to coordinate and to be included in the transition meeting to discuss services available for families under Part B. If an LEA is unable to attend the meeting, arrangements must be made for its involvement through other means..."

New: "With parental consent for the SPOE (system point of entry) to hold a transition conference, the LEA agrees to be contacted by the service coordinator to coordinate and to be included in the transition conference to discuss services available for families under Part B. If an LEA is unable to attend the meeting, arrangements must be made for its involvement through other means..." This change was made to directly align with federal regulatory requirements (34 CFR § 300.124 and 34 CFR § 303.209) by clarifying the roles of parental consent and First Steps/LEA responsibilities related to the transition conference. IDOE Special Programs Frequently Asked Questions (FAQ) IDOE Special Programs FAQ provides the most accurate, up-to-date information regarding Indiana's transition from Indiana IEP (IIEP) to IDOE Special Programs. As the state prepares for the official go-live date on Friday, July 18, this document is intended to support educators, administrators, and LEA technical contacts by addressing common questions and clarifying key processes related to certification, data migration, student transfers, and system functionality. The information provided reflects current guidance and best practices to ensure a smooth transition and continued compliance with state and federal requirements. Statewide IEP System Training Materials The transition to PowerSchool Special Programs as the statewide IEP system has begun. Current Indiana IEP system users should have received an email notification with directions for accessing online and on-demand trainings via Schoology and information about optional online live trainings. This email will come from a PowerSchool address, so check your spam/junk folders if you did not receive it. There are two sets of training. The first will be for district-wide administrators. The second is for school users, which includes building administrators who currently use the system. Users have been assigned to a group based on their LINK accounts and current Indiana IEP roles. Live training has begun for district-wide administrators, and live training will start in August for school users. Note again that on-
