Data Entry Reminders

School calendars must be entered into Data Exchange (DEX) prior to entering any student-level data. School calendars may be updated throughout the year so you will not be locked into dates by entering your school calendar in DEX. If you work with an SIS, please contact your SIS for any issues. If you use templates, please file a Help Desk ticket for any necessary assistance.

- **School and Corporation Profile Amendment Window**
- The school and corporation profile amendment submission window for the 2024-2025 school year is open until Sunday, August 31. In order to ensure IDOE maintains accurate information, all schools and corporations must provide notice when changes are made that affect school openings, closures, and reconfigurations.

Choice School Application for the 2025-2026 School Year

The application for schools to apply to participate in the Choice Scholarship Program for the 2025-2026 school year is currently open. The packet of application materials is posted on the Choice Scholarship Program website and in the Non-Public School Community on Moodle. Schools should only submit their application to be a Choice school after the admission, tuition, fee, and discount policies are final. Accreditation must be through the State Board of Education (SBOE) or through an agency recognized by SBOE and must be in good standing for the entire 2025-2026 school year. A list of accrediting agencies recognized by SBOE is posted on the Accreditation

Information on the submission process can be found here. Schools that have changes in grade configurations will not be able to access those grade levels in the student Choice application until the profile amendment has been approved through the Office of

website. The deadline to apply to be a participating Choice school for the 2025-2026 school year is Monday, September 1.

Choice Student Application The window to submit student Choice applications for Period 1 of the 2025-2026 school year is also currently open, and will remain open through Monday, September 1. The application is available to schools that have been approved for participation in Choice for the 2025-2026 school year.

Choice system. LINK roles are assigned by your school's LINK Security Coordinator. **Communications**

New this year, the application must be accessed using the LINK portal, using the "Choice Scholarship" tile on the LINK dashboard. Only those with a LINK role of Superintendent, Principal, LEA Administrator, and/or School Administrator will be able to access the new


