# Indiana Academic Standards Mathematics: Grade 2

## Introduction

The Indiana Academic Standards for Mathematics are the result of a process designed to identify, evaluate, synthesize, and create highest-quality, rigorous standards for Indiana students. The standards are designed to ensure that all Indiana students, upon graduation, are prepared for both college and career opportunities. In alignment with Indiana's Every Student Succeeds Act (ESSA) plan, the academic standards reflect the core belief that all students can achieve at a high level.

## What are the Indiana Academic Standards?

The Indiana Academic Standards are designed to help educators, parents, students, and community members understand what students need to know and be able to do at each grade level, and within each content strand, in order to exit high school college and career ready. The academic standards should form the basis for strong Tier 1 instruction at each grade level and for each content area for all students, in alignment with Indiana's vision for Multi-Tiered Systems of Supports (MTSS). While the standards have identified the academic content or skills that Indiana students need to be prepared for both college and career, they are not an exhaustive list. Students require a wide range of physical, social, and emotional support to be successful. This leads to a second core belief outlined in Indiana's ESSA plan that learning requires an emphasis on the whole child.

While the standards may be used as the basis for curriculum, the Indiana Academic Standards are not a curriculum. Curricular tools, including textbooks, are selected by the district/school and adopted through the local school board. However, a strong standards-based approach to instruction is encouraged, as most curricula will not align perfectly with the Indiana Academic Standards. Additionally, attention should be given at the district and school-level to the instructional sequence of the standards as well as to the length of time needed to teach each standard. Every standard has a unique place in the continuum of learning omitting one will certainly create gaps - but each standard will not require the same amount of time and attention. A deep understanding of the vertical articulation of the standards will enable educators to make the best instructional decisions. The Indiana Academic Standards must also be complemented by robust, evidencebased instructional practices, geared to the development of the whole child. By utilizing well-chosen instructional practices, social-emotional competencies and employability skills can be developed in conjunction with the content standards.

## PROCESS STANDARDS FOR MATHEMATICS

The Process Standards demonstrate the ways in which students should develop conceptual understanding of mathematical content, and the ways in which students should synthesize and apply mathematical skills.

| PS.1: Make sense of <br> problems and <br> persevere in solving <br> them. | Mathematically proficient students start by explaining to themselves the meaning of a problem and <br> looking for entry points to its solution. They analyze givens, constraints, relationships, and goals. They <br> make conjectures about the form and meaning of the solution and plan a solution pathway, rather than <br> simply jumping into a solution attempt. They consider analogous problems and try special cases and <br> simpler forms of the original problem in order to gain insight into its solution. They monitor and evaluate <br> their progress and change course if necessary. Mathematically proficient students check their answers to <br> problems using a different method, and they continually ask themselves, "Does this make sense?" and "ls <br> my answer reasonable?" They understand the approaches of others to solving complex problems and <br> identify correspondences between different approaches. Mathematically proficient students understand <br> how mathematical ideas interconnect and build on one another to produce a coherent whole. |
| PS.2: Reason abstractly <br> and quantitatively. | Mathematically proficient students make sense of quantities and their relationships in problem situations. <br> They bring two complementary abilities to bear on problems involving quantitative relationships: the ability <br> to decontextualize-to abstract a given situation and represent it symbolically and manipulate the <br> representing symbols as if they have a life of their own, without necessarily y attending to their referents- <br> and the ability to contextualize, to pause as needed during the manipulation process in order to probe into |

Mathematically proficient students understand and use stated assumptions, definitions, and previously established results in constructing arguments. They make conjectures and build a logical progression of statements to explore the truth of their conjectures. They analyze situations by breaking them into cases and recognize and use counterexamples. They organize their mathematical thinking, justify their conclusions and communicate them to others, and respond to the arguments of others. They reason inductively about data, making plausible arguments that take into account the context from which the data arose. Mathematically proficient students are also able to compare the effectiveness of two plausible arguments, distinguish correct logic or reasoning from that which is flawed, and-if there is a flaw in an argument-explain what it is. They justify whether a given statement is true always, sometimes, or never. Mathematically proficient students participate and collaborate in a mathematics community. They listen to or read the arguments of others, decide whether they make sense, and ask useful questions to clarify or improve the arguments.

Mathematically proficient students apply the mathematics they know to solve problems arising in everyday life, society, and the workplace using a variety of appropriate strategies. They create and use a variety of representations to solve problems and to organize and communicate mathematical ideas. Mathematically proficient students apply what they know and are comfortable making assumptions and approximations to simplify a complicated situation, realizing that these may need revision later. They are able to identify important quantities in a practical situation and map their relationships using such tools as diagrams, two-way tables, graphs, flowcharts and formulas. They analyze those relationships mathematically to draw conclusions. They routinely interpret their mathematical results in the context of the situation and reflect on whether the results make sense, possibly improving the model if it has not served its purpose.

Mathematically proficient students consider the available tools when solving a mathematical problem. These tools might include pencil and paper, models, a ruler, a protractor, a calculator, a spreadsheet, a computer algebra system, a statistical package, or dynamic geometry software. Mathematically proficient students are sufficiently familiar with tools appropriate for their grade or course to make sound decisions about when each of these tools might be helpful, recognizing both the insight to be gained and their

limitations. Mathematically proficient students identify relevant external mathematical resources, such as digital content, and use them to pose or solve problems. They use technological tools to explore and deepen their understanding of concepts and to support the development of learning mathematics. They use technology to contribute to concept development, simulation, representation, reasoning, communication and problem solving.

Mathematically proficient students communicate precisely to others. They use clear definitions, including correct mathematical language, in discussion with others and in their own reasoning. They state the meaning of the symbols they choose, including using the equal sign consistently and appropriately. They express solutions clearly and logically by using the appropriate mathematical terms and notation. They specify units of measure and label axes to clarify the correspondence with quantities in a problem. They calculate accurately and efficiently and check the validity of their results in the context of the problem. They express numerical answers with a degree of precision appropriate for the problem context.

Mathematically proficient students look closely to discern a pattern or structure. They step back for an overview and shift perspective. They recognize and use properties of operations and equality. They organize and classify geometric shapes based on their attributes. They see expressions, equations, and geometric figures as single objects or as being composed of several objects.

Mathematically proficient students notice if calculations are repeated and look for general methods and shortcuts. They notice regularity in mathematical problems and their work to create a rule or formula. Mathematically proficient students maintain oversight of the process, while attending to the details as they solve a problem. They continually evaluate the reasonableness of their intermediate results.

## MATHEMATICS: Grade 2

The Mathematics standards for Grade 2 are supplemented by the Process Standards for Mathematics.
The Mathematics standards for Grade 2 are made up of five strands: Number Sense, Computation and Algebraic Thinking, Geometry, Measurement, and Data Analysis. The skills listed in each strand indicate what students in Grade 2 should know and be able to do in Mathematics.

|  | NUMBER SENSE |

| 2.NS.1 | Count by ones, twos, fives, tens, and hundreds up to at least 1,000 from any given number. |
| 2.NS.2 | Read and write whole numbers up to 1,000. Use words, models, standard form and expanded form to represent and <br> show equivalent forms of whole numbers up to $1,000$. |
| 2.NS.3 | Plot and compare whole numbers up to 1,000 on a number line. |
| 2.NS.4 | Match the ordinal numbers first, second, third, etc., with an ordered set up to 30 items. |
| 2.NS.5 | Determine whether a group of objects (up to 20) has an odd or even number of members (e.g., by placing that number <br> of fobjects in two groups of the same size and recognizing that for even numbers no object will be left over and for odd <br> numbers one object will be left over, or by pairing objects or counting them by 2s). |

Understand that the three digits of a three-digit number represent amounts of hundreds, tens, and ones (e.g., 706
2.NS. 6 equals 7 hundreds, 0 tens, and 6 ones). Understand that 100 can be thought of as a group of ten tens - called a "hundred." Understand that the numbers 100, 200, 300, 400, 500, 600, 700, 800, 900 refer to one, two, three, four, five, six, seven, eight, or nine hundreds (and 0 tens and 0 ones).

Use place value understanding to compare two three-digit numbers based on meanings of the hundreds, tens, and ones digits, using >, =, and < symbols to record the results of comparisons.

## COMPUTATION AND ALGEBRAIC THINKING

| 2.CA.1 | Add and subtract fluently within 100. |

| 2.CA.2 | Solve real-world problems involving addition and subtraction within 100 in situations of adding to, taking from, putting <br> together, taking apart, and comparing, with unknowns in all parts of the addition or subtraction problem (e.g., by using <br> drawings and equations with a symbol for the unknown number to represent the problem). Use estimation to decide <br> whether answers are reasonable in addition problems. |
| 2.CA.3 | Solve real-world problems involving addition and subtraction within 100 in situations involving lengths that are given in <br> the same units (e.g., by using drawings, such as drawings of rulers, and equations with a symbol for the unknown <br> number to represent the problem). |
| 2.CA.4 | Add and subtract within 1000, using models or drawings and strategies based on place value, properties of operations, <br> and/or the relationship between addition and subtraction; describe the strategy and explain the reasoning used. <br> Understand that in adding or subtracting three-digit numbers, one adds or subtracts hundreds and hundreds, tens and <br> tens, ones and ones, and that sometimes it is necessary to compose or decompose tens or hundreds. |
| 2.CA.5 | Use addition to find the total number of objects arranged in rectangular arrays with up to 5 rows and up to 5 columns; <br> write an equation to express the total as a sum of equal groups. |
| 2.CA.6 | Show that the order in which two numbers are added (commutative property) and how the numbers are grouped in <br> addition (associative property) will not change the sum. These properties can be used to show that numbers can be <br> added in any order. |

| 2.G.1 | Identify, describe, and classify two- and three-dimensional shapes (triangle, square, rectangle, cube, right rectangular <br> prism) according to the number and shape of faces and the number of sides and/or vertices. Draw two-dimensional <br> shapes. |
| 2.G.2 | Create squares, rectangles, triangles, cubes, and right rectangular prisms using appropriate materials. |
| 2.G.3 | Investigate and predict the result of composing and decomposing two- and three-dimensional shapes. |
| 2.G.4 | Partition a rectangle into rows and columns of same-size (unit) squares and count to find the total number of same-size <br> squares. |
| 2.G.5 | Partition circles and rectangles into two, three, or four equal parts; describe the shares using the words halves, thirds, <br> half of, a third of, etc.; and describe the whole as two halves, three thirds, four fourths. Recognize that equal parts of <br> identical wholes need not have the same shape. |

## MEASUREMENT

| 2.M.1 | Describe the relationships among inch, foot, and yard. Describe the relationship between centimeter and meter. |

| 2.M.2 | Estimate and measure the length of an object by selecting and using appropriate tools, such as rulers, yardsticks, meter <br> sticks, and measuring tapes to the nearest inch, foot, yard, centimeter and meter. |
| 2.M.3 | Understand that the length of an object does not change regardless of the units used. Measure the length of an object <br> twice using length units of different lengths for the two measurements. Describe how the two measurements relate to <br> the size of the unit chosen. |
| 2.M.4 | Estimate and measure volume (capacity) using cups and pints. |
| 2.M.5 | Tell and write time to the nearest five minutes from analog clocks, using a.m. and p.m. Solve real-world problems <br> involving addition and subtraction of time intervals on the hour or half hour. |
| 2.M.6 | Describe relationships of time, including: seconds in a minute; minutes in an hour; hours in a day; days in a week; and <br> days, weeks, and months in a year. |
| 2.M.7 | Find the value of a collection of pennies, nickels, dimes, quarters and dollars. |
