Preliminary Student Results Available in the Centralized Reporting System (CRS) Corporations and schools can begin accessing preliminary student results in CRS.	April 6, 2026
Last Day to Ship Paper Materials  All paper test books and secure materials must be shipped to CAI no later than five school days after testing is complete, or by date listed.	May 15, 2026
Final Student Results Available in CRS Individual students results are available in CRS. Final reports may be downloaded in several formats. No printed copies of Individual Student Reports (ISRs) or student score labels will be shipped to schools.	July 1, 2026

Indiana's Alternate Measure (I AM) measures student achievement and growth according to Indiana's Content Connectors aligned to the Indiana Academic Standards. I AM is the summative accountability assessment for students with significant cognitive disabilities in grades 3-8 and high school. It assesses English/Language Arts (grades 3-8 and 10), Mathematics (grades 3-8 and 10), Science (grades 4, 6, and Biology), and Social Studies (grade 5).
