SAT STC Workshop #1 This workshop will provide an overview of policies, procedures, test administration timelines, available resources, and communication planning prior to Spring 2026 SAT School Day testing.	Early December
College Board's Interactive Coordinator Checklist Available STCs gain access to College Board's interactive checklist containing all tasks and deadlines for the spring 2026 test administration.	Monday, December 1
Services for Students with Disabilities (SSD) Coordinator Webinar STCs must appoint an SSD Coordinator within SSD Online. The SSD Coordinator will complete this training to ensure accommodations are successfully administered for the SAT School Day.	Tuesday, December 2
Technical Readiness Webinar  This webinar will provide Technology Coordinators with an overview of the digital testing platform, system requirements, and a digital readiness timeline.	January 6, 2026

Deadline to Submit College Board Approved Accommodation Requests & English Learner (EL) Extended Time  This deadline ensures that accommodations are requested in time to be reviewed before testing. Extended time support for EL students must be requested in SSD Online but does not require approval.	January 12, 2026	
College Board's Required Online Training Available This training is required for all STCs, proctors, and technology monitors. STCs have the option to train proctors and technology monitors in person, or proctors and technology monitors can complete the online training online individually. Hall and room monitors can review a College Board-provided PowerPoint to meet their training requirement.	Week of January 26 through February 23, 2026	
Access to College Board's State Data Management System (SDMS) STCs, CTCs, and SSD Coordinators gain access to SDMS to manage student registration.	January 28, 2026	
Access to College Board's Test Day Toolkit STCs gain access to Test Day Toolkit and may add other test staff as needed.	Week of February 2, 2026	
SAT STC Workshop #2 This workshop will provide an overview of student readiness, required online training, testing timelines, available checklists, irregularity reports, and post-testing activities.	February 11, 2026	
Conduct Student Readiness Activities  Students can opt in to BigFuture School and Connections as well as send up to four free score sends to colleges of their choice. STCs should collaborate with Technology Coordinators to conduct final student readiness activities prior to spring testing.	Week of February 16, 2026	
Paper Testing Materials Shipments Paper testing materials will be shipped to approved paper-testing schools, students with approved accommodations in SSD Online, and schools with individual students approved for paper testing due to special circumstances.	Week of February 16 through March 12, 2026	
SAT Q&A Sessions IDOE will host two Q&A sessions for educators to address questions regarding the administration of the Digital SAT School Day prior to the operational testing window.
