<u>ParaPathways Assessment for Paraprofessionals</u> Educational Testing Service (ETS) is replacing the existing ParaPro assessment #1755 with the updated ParaPathways assessment #5757, during a one-year transition period. The ParaPathways assessment includes two subtests: reading/writing (subtest 5758) and math (subtest 5759). No IDOE-issued educator license is based on passing ParaPro or ParaPathways. These tests are used as a local option for determining the highly qualified status of paraprofessionals employed by the LEA. From September 1, 2025, until August 31, 2026, both paraprofessional assessments will be available. On September 1, 2026, only ParaPathways will be available.
