A Message from Dr. Katie Jenner

This week is Severe Weather Preparedness Week, a time when many schools across Indiana participate in the statewide tornado drill before the spring storm season begins. Many schools also use this week to teach students about different types of severe weather and what to do both before and during a storm to stay informed and safe. This includes **Gold Academy** in Decatur Township (Indianapolis), where I was able to join Indiana Department of Homeland Security Director Jonathan Whitham on Monday.

Even as we focused on planning and practice with their third grade students, several schools across the state had to quickly shift into response mode over the next two days as late-winter storms moved through Indiana, impacting communities and even some of our school buildings. Thank you for working to keep our students and staff safe and for supporting our families whenever severe weather strikes!



This week is also Civic Learning Week, a time to highlight the vital role civics plays in safeguarding the strength and future of our country. If you asked parents and educators about the primary purpose of K-12 education, most would say, "to prepare students for the future." Of course, we know that means helping students excel academically, and also preparing students with the skills and experiences they need to be informed, engaged, and productive citizens. Strong civics education ensures that each student understands the constitutional principles, individual liberties, and personal responsibilities that are central to upholding our government and our freedoms. This is essential to the success of every graduate, as well as the health and vitality of our communities, our state, and our Nation.

This is why Indiana has become a national leader in civics education, with a number of initiatives in recent years to promote civic literacy for every student. So, in honor of Civic Learning Week, let's take a look at how educators and schools across the state are preparing our future leaders and changemakers!

- Indiana's Profile of a Graduate** – Since 2021, civic literacy has been elevated as one of the five key characteristics of an Indiana Graduate Prepared to Succeed—this is in direct response to feedback from Hoosiers across the state about what graduates need the most.
- Kindergarten through Grade 8** – All K-8 social studies standards contain government/civics standards, including an emphasis on the foundations of government, functions of government, and the role of citizens.
- New sixth grade civics course** – Beginning with the 2023-2024 school year, all sixth grade students are required to take a civics course.
- New Indiana diploma and readiness seals** – Indiana's new diploma, which is currently being implemented in a number of schools statewide and is effective for all students beginning with the class of 2029, requires every student to take U.S. History and U.S. Government as part of the basic diploma requirements.
- New school accountability model** – Just last week, the Indiana State Board of Education unanimously approved a new A-F accountability model, which values when students demonstrate a strong understanding of civics and government on the ILEARN U.S. Government End-of-Course Assessment (this assessment is optional per statute). This new model also goes further than any prior iteration of the state's school accountability model to incorporate social studies in grades 4-6, thus ensuring more students have a robust understanding of civics and government.
- Looking ahead** – For students who choose to continue their education beyond K-12, our state's public higher education partners also play an essential role in equipping students for successful, rewarding careers, as well as preparing students to be good citizens. Moving forward, we will launch a comprehensive exploration to identify how we can best measure civic literacy in both K-12 and higher education.

As we think about how we can best prepare students for life after high school, civic literacy is one of a range of skills every student needs to realize their full potential. Thank you to the Indiana Bar Foundation, as well as the Benjamin Harrison Presidential Site, for their continued partnership and advocacy in this area, and thank you for the role you play in empowering students through civic learning and strengthening our Nation through education. As always, thank you for all that you do for Indiana students.

REMINDER: 2025-2026 Petition to Seek Performance-Based State Accreditation Submission Window

The submission window for non-public schools to submit a [petition for performance-based state accreditation](#) will close on Tuesday, March 31. Petitions must be completed and submitted to the Indiana Department of Education (IDOE) prior to the school year for which accreditation would begin. Schools are encouraged to submit a [Notice of Intent](#) form to alert IDOE of their intent to submit a petition. NEW: SAT School Day 2026 Data Analysis Workshops

NEW: Universal Mathematics Screener Grades K-2 Frequently Asked Questions

REMINDER: 2026-2027 Formative (Interim) Assessment Grant Approved Assessments

The Indiana State Board of Education approved assessment programs, specific universal reading screeners, and two preferred universal mathematics screeners for kindergarten through grade two for use with the 2026-2027 Formative (Interim) Assessment Grant. NEW: Fall 2026 Early Learning Assessment System Opt-In – Indiana Kindergarten Readiness Assessment (IKRA) and ISPROUT

As part of Indiana's system to measure and support kindergarten readiness, Indiana's IKRA will be available to all public, charter, and non-public schools as an opt-in assessment for kindergarten students in fall 2026. The [IKRA opt-in window is now open](#) through Friday, May 15. The [ISPROUT opt-in window for students ages three through five](#) is also open for fall 2026. ISPROUT will continue to be required for children in special education, as well as children utilizing On My Way Pre-K funding. Administering ISPROUT is also required for all programs receiving High-Quality Curricular Materials Grant funding in 2025, however, any program serving children ages three through five is able to opt-in. If you participated in the IKRA or ISPROUT previously, you must still complete an opt-in form for 2026-2027. Contact IDOE's [Office of Assessment](#) with any questions.

REMINDER: Implementing Advanced Middle School Mathematics

IDOE created this [implementation guide](#) to support middle schools in implementing automatic enrollment in advanced mathematics courses. This guide provides administrators and school leaders with a structured resource for planning and decision-making. It helps evaluate local conditions, explore feasible models, and design systems that ensure high-quality advanced math experiences for students. The guide also serves as a shared reference for administrators, counselors, and teachers to align on advanced math goals within a school corporation. REMINDER: Fiscal Year (FY) 2027 Indirect Cost Rates Application Information

The window to apply for Indirect Cost Rates is open until Tuesday, March 31. Restricted and unrestricted indirect costs rates are calculated and certified only to entities that provide Form 9 financial information. This is a competitive, multi-year, multi-million-dollar grant and must include a well-developed vision and intentional strategic plan to innovate or transform the educational experience for your students and community. Eligibility for this grant extends to all schools currently identified as CSI and TSI under Indiana's Every Student Succeeds Act (ESSA) plan. NEW: Maintenance of Effort (MOE) for Part B Funding

The window to submit Year 5 Compliance and Year 6 Eligibility for the Individuals with Disabilities Education Act (IDEA) Part B Fiscal Year 2027 funding is now open. MOE workbooks are due within the [grant management system](#) by Friday, March 27. Local educational agencies (LEAs) without an approved MOE should contact their assigned fiscal specialist before completing their workbook. New charter schools that have not received an MOE workbook will receive a workbook via email with a different due date. December 1, 2024, child counts are available in the Office of Special Education Moodle Community (i.e., Fiscal -- Part B Grants for Special Education -- FY26 Grant Information -- Maintenance of Effort -Year 5). NEW: Education Benefit Review Pilot Grant Recipients

IDOE's Office of Special Education is pleased to announce the 15 recipients of the 2026-2027 Education Benefit Review Pilot Grant. The Education Benefit Review is a structured, in-depth examination of the supports and services provided to students with disabilities. This process is designed to ensure that each student receives a free, appropriate public education, as required under federal law. Through this pilot, participating districts will engage in a comprehensive review that strengthens decision-making, improves service delivery, and promotes meaningful educational outcomes for students with disabilities. NEW FROM THE INDIANA BAR FOUNDATION AND ICIVICS: Indiana Civics Summit and Educator Convening on Thursday, April 9

This one-day conference brings together educators and youth from across the state to explore Indiana's civic health, America's 250th anniversary, and themes of civility and leadership engagement. This year's summit will also feature the ICivics Educator Convening, a dedicated learning track designed with classroom impact in mind. To support educator participation, ICivics will cover registration costs for a limited number of K-12 educators. If you are an educator, use code CIVICS26 for free registration.
