



**Indiana School Scholarship Tax Credit Program Report  
2011-2012 through 2016-2017**

Indiana Code 20-51-3-6 requires Scholarship Granting Organizations (SGOs) to provide the Indiana Department of Education with annual and financial report information. As part of the annual report, SGOs are required to provide the Department with the following information:

- (1) The total number and total dollar amount of contributions received during the previous school year, and,
- (2) The total number and total dollar amount of scholarships awarded during the previous school year.

The information provided by each participating SGO in their annual report is provided below for the 2011-2012 through 2016-2017 school years.
