Test Information Distribution Engine (TIDE) Refresh Corporations and non-public schools must ensure enrollment and demographic data is correct in their student information system (SIS). The Indiana Department of Education (IDOE) will include SIS updates via nightly Data Exchange. Student enrollment and accommodations data also begin populating within TIDE via IDOE nightly file transfer or Data Exchange.	Monday, August 3*		
Test Administrator (TA) Certification Course Available TAs must complete the required course using their TIDE user credentials each school year. TAs can initiate ILEARN and IREAD test sessions upon completion of this course.	Monday, August 10
