## INSHARP CERTIFICATION

Small Hoosier workplaces that operate exemplary workplace safety and health management systems may be eligible for participation in the **Indiana Safety and Health Achievement Recognition Program (INSHARP)**.




INSHARP participants are recognized as industry leaders in workplace safety and health, and also receive an exemption from programmed IOSHA inspections for one to three years.

## REQUEST

Our assigned INSafe team member begins the process by working directly with the employer, gaining an understanding of the facility or worksite's safety and health programs, and defining the needs and goals for the site. Preparation and scope-of-visit are the first steps of the INSafe process.



## ON-SITE VISIT

On the scheduled date, your assigned INSafe team member arrives to walk the workplace alongside the employer or safety director. During the visit, we identify deficiencies or gaps in existing safety and health programs, locate and help correct hazards, and perform a total assessment of the site's necessary steps for compliance.



## CLOSING

Upon completing the on-site visit, INSafe then provides employers with a full technical report, findings (which include any identified hazards if applicable and recommendations for correction), best practices, sample programs, and potential resources or information to help structure preventative and proactive workplace safety and health programs.
