Management Statistics


- Other Statistics in this report are "management statistics", for use in managing Departmental processes


Indiana Non-Fatal Injury & Illness Incident Rates

Discussion: The 2010 rate will be released by the BLS in October 2011. The 2011 objective is 4.0 non-fatal injuries and illnesses per 100 employees.


Incident Rate =

per 100 Employees





2006-2010 Number of IOSHA Inspected Fatalities




2011 IOSHA Inspected Fatal Events



IOSHA: Number of Inspections


Discussion: Inspections from recent months may not be finalized and have not been entered into the NCR system. Therefore an increase in recent months will increase over the following quarter.













IOSHA: Percent of Inspections with Violations












IOSHA: Penalties due paid within 30 days





Discussion: The data does not include cases that are outstanding but less than 30 days old. Nor does the data include BSR cases.

Percent of IOSHA Safety Orders which result in Contests




Board of Safety Review (BSR): Cases Closed 2006-present
