## Motor Carrier Calendar Notes

### November 1, 2004

Third quarter Intrastate Motor Carrier Fuel Tax (Form MCFT-101) and Interstate International Fuel Tax Agreement (IFTA-101) returns are due. (Form MCFT-101 is available on our website at [www.in.gov/dor/mcs/formlist.html#mc](http://www.in.gov/dor/mcs/formlist.html#mc)).

### November 1, 2004

Claims for Proportional Use Credit are due. Form MCS-1789 is available on our website at [www.in.gov/dor/mcs/formlist.html#mc](http://www.in.gov/dor/mcs/formlist.html#mc).

### November 30, 2004

2005 BAS-1A renewals for Interstate Single State Registration (SSRS) and/or US DOT (Intrastate) are due. Renewal forms will be mailed in September.

## 2005 Interstate and/or Intrastate Renewals

Your annual Interstate Single State Registration (SSRS), and/or US DOT (Intrastate) renewal applications (Form BAS-1A) were mailed out in late August. Your renewal application is due back in our office on or before November 30, 2004, in order for your credential(s) to be mailed to you by the end of the year. **PLEASE NOTE**, if you are a private carrier of non-hazardous materials you **will not** receive a 2005 renewal, because private non-hazardous materials carriers are required to register only one time.

## IFTA Exchange Rate for Third Quarter

The third quarter of 2004 International Fuel Tax Agreement (IFTA) fuel tax return US/Canada exchange rate is 1.3640 - 0.7331.

## IRP Reminder

Please notify the International Registration Plan (IRP) Unit of any entity or operational changes, such as a shift from a sole proprietor to a corporation. Important changes that have not been reported immediately can have a negative effect or impact on your current IRP account.

## IFTA/Motor Fuel Taxes

Your renewal applications for IFTA or Motor Carrier Fuel Tax license and decals were mailed out June 15, 2004, and were due in our office by September 1, 2004. Make sure you have received your renewal application. If you have not, contact us at 317-615-7345.

We will begin mailing license cards and decals on November 15, 2004. Our goal is to provide you with ample time to place the license card and decal in your vehicles.
