Return Postmark Processing Rule If the Transmission File did not fail IN-TRH-004, the Postmark Date for each Return in the Transmission File is the IDORTransmission\Timestamp. If the Transmission File did fail IN-TRH-004, IDOR requires the entire file be retransmitted with a new Filename and a new Timestamp.

Payment Postmark Processing Rule The Postmark Date for a payment in the Transmission File is the later of the IDORTransmission\Timestamp and the IDORTransmission\ReturnState\FinancialTransaction\StatePayment\RequestedPaymentDate. This means that is is possible for a Return to be timely and a Payment to be late should the RequestedPaymentDate be after the Due Date.
