

## Navigating the Legal FinDOR Site

## Instructions

To access the Legal FinDOR tool go to <u>www.in.gov/dor/</u>. This is the Department's main website. The DOR homepage appears.

On the left-hand side of the DOR Home page is the **DOR HOME** site navigation sidebar.





Select the **Tax Library** link from the DOR HOME site navigation sidebar menu.

The Tax Library page appears. Select the **Legal Resources** link from this page.





The Legal Resources page opens. Select the **Legal FinDOR** link to navigate to the Legal FinDOR page. The LEGAL FINDOR homepage appears which describes how to use this new resource. Please note your username and password. Both will be "dorsearch."
