EFFECTIVE: Immediately

To date, Traffic Project submittals have been using old naming conventions, such as Preliminary Plans or Preliminary Field Check. To align Traffic Project submittals with road and bridge projects, the submittal process has been updated to a Stage submittal naming convention. In addition, separate traffic plan submittals will be required at the different stages to ensure that traffic details incorporated with road and bridge projects are being received by the Traffic Division for review.

Traffic Project Submittal Naming Convention

The traffic submittal process had been updated to a Stage submittal naming convention and submittal items have been added to better represent the Stage submission process. Previous submittal naming conventions have been noted in parentheses to assist designers in transferring current projects to the new stage submittal process.

<u>Separate Traffic Plan Submittal</u>

Road and bridge projects that include traffic details must submit a separate set of traffic plans in ERMS for review in accordance with the new IDM section, 14-1.02(09), Traffic Signal, Signing, and Lighting Review Procedure. This new section gives direction on the traffic plan submittal, including when a separate traffic plan set must be uploaded and what is to be included. Note, all traffic plan submittals must include the name and contact information for the Traffic Designer.

Two new ERMS naming conventions have been added, one to depict the stage submittal and the second to incorporate a new submittal item, Lighting Design Model-LtgDgnMod.

The file naming format for a traffic plan submittal into ERMS is as follows:

[Submittal] [Description] [Des No.] for Traffic Services STG1 or STG2 or STG3.

Examples: TRAF Plans 0900010 for Traffic Services STG1 TRAF LtgDgnMod 0900010 for Traffic Services STG2

Subsequent sections of the IDM Chapter 14 have been revised. The table at the end of this memo notes revisions to each section.
