SUBJECT: Status of Existing Road and Design Memoranda

EFFECTIVE: Immediately on All Applicable Road, Bridge, and Traffic Projects

The current status of all Road and Design Memoranda, exclusive of Bridge Design Memoranda, which will be covered in Part VI, Structural Design, of the new INDOT Design Manual, have been reviewed recently. All Road and Design Memoranda issued prior to June, 1998, are either obsolete or superseded by subsequent design memoranda, specifications, or the INDOT Design Manual, except for the following:
