**SUBJECT: Snowplowable Raised Pavement Marker Castings**

**EFFECTIVE: April 19, 2006, Letting**

The Operations Support Division's Logistical Support Section has a number of refurbished subject castings which may be used only on Department-maintained non-Interstate routes. If snowplowable raised pavement markers are required for such a project, the Department's project manager should determine the quantity required, then contact the Logistical Support Section manager to determine if that number of castings is available. If so, the Department's project manager should incorporate Recurring Special Provision 808-T-151 into the contract set. Quantities for the pay item 808-01226 Snowplowable Raised Pavement Marker Casting, Install, pay unit Each; should be included in the Estimate of Quantities and Cost Estimate.

REFURBISHED SNOWPLOWABLE RAISED PAVEMENT MARKER CASTINGS

The Standard Specifications are revised as follows:

SECTION 808, LINE 361, INSERT AS FOLLOWS:

**808.11 Snowplowable Raised Pavement Markers**

~~Snowplowable~~ *Refurbished snowplowable raised pavement markers castings with new reflectors shall be used as supplemental delineation at the locations shown on the plans or as directed. Refurbished marker castings shall be picked up from the Procurement and Distribution Center. The manager can be contacted at (317) 591-5248. The Contractor shall furnish and install the prismatic reflectors.*

SECTION 808, LINE 487, INSERT AS FOLLOWS:

*removed. Refurbished marker castings will be measured by the number installed. Prismatic reflectors will be measured by the number furnished and installed.*

SECTION 808, LINE 503, INSERT AS FOLLOWS:

*be paid for at the contract unit price per each. Refurbished marker castings installed will be paid for at the contract unit price per each. Prismatic reflectors will be paid for at the*

SECTION 808, AFTER LINE 523, INSERT AS FOLLOWS:

*Snowplowable Raised Pavement Marker Casting, Install..... EACH*

SECTION 808, AFTER LINE 543 INSERT AS FOLLOWS:

*The costs of picking up the refurbished marker castings and delivering them to the project will be included in the contract unit price of snowplowable raised pavement marker casting, install. The cost of furnishing and installing the prismatic reflectors on refurbished snowplowable pavement marker castings shall be included in the cost of snowplowable pavement marker casting, install.*
