Dennis Wimer, IDVA and IDVA Division Reports

- Joy from IVH moving on after little more than 1 year, 2 years interim. Working towards positive direction with continuous improvement. COVID outbreaks under control
- Mr. Leirer wants to see reports on new MFRF format for IVH and IVC.
- Cemetery Slowing down in winter months, meeting with National Cemetery regarding \$7.5 million grant beginning on December 14. New roof needed around \$250,000
- Director Wimer to send out email regarding wreaths when they are placed.
- SAA hired a new staff member that doe outreach to new businesses. This is new for SAA, previously it was a contractor.
- Chairman Steuterman requests head of SAA to conduct report to Commission periodically.
- License Plates, CVSO's, Tuition Fee/Exempt IDVA partnering with Fed VA regarding the Virtual Veterans Experience and explains program rollout.
- Chairman Steuterman suggest commission members to sit down with a CVSO to learn about how their day is conducted.





# Gabrielle Owens, Military Family Relief Fund Update

- Significant increases in MFRF applications once the program was adjusted. The online application contributed to this. Walk-ins have increased.
- Day to day MFRF application is heavy on referrals to include free financial counseling, DWD, IN Legal Services and other partners. Per veteran, brochure that was sent saved their life.
- Dir. Wimer states the April meeting commission will review how OHP program rolled out and how it should move forward.
- Mr. Coley discussed the MFRF program using Salesforce and benefits gained from it. Also, addressed concern on proper usage of taxpayer dollars.

# Joe Devito, MFRF Outreach Plan Update

- MFRF increase in application averages at 30 per month, then over 80 per month after the ads and media exposure. Twenty percent increase once the recent campaign started.
- Website impressions are increasing, now moving onto Facebook to second part of campaign. Social media across the board has had an uptake except for LinkedIn. Which has still gone from 50 to 300.
- Event sponsorship program has shown good success. Welcome Home Vietnam Veterans has been a large focus with CVSO's, 22 approved applications out of 25. IDVA had a vendor table at 18 of them and a total of \$11,000 has been awarded.
- Chairman Steuterman expressed the how to get Vietnam era veterans to reach out regarding their experience and how important it is to reach out to them. The program has now visited about 30 counties. The funding is currently sufficient.
- Mr. Leirer asks about IDVA's other divisions and that the same focus is considered towards them as the CVSO's regarding the events and programs. Also, states that Jill Fewell said she conducted 60+ events in 2021.
- CVSO's will be challenged to host an event in 2022 regarding the Vietnam Veterans.
- Dir. Wimer expresses the difference between the programs and dollars spent. Revenues projected for 2022 fiscal year is \$2.2 million from license plates, which should reflect the same amount of funds available for MFRF. However, staffing will become an issue to process the applications. The need to focus on money out to veterans surpass any amount spent on marketing.
- Chairman Steuterman thanks Lynn from MFRF and expressed her desire to have her at the table for all commission meetings.

# Gabrielle J. Owens, Grants for Veterans' Services

- Eleven awards have been granted.
- Each quarter there is mini compliance monitoring.
- Intecare-Working with them to rectify issues.
- Following up with other organizations with \$0 grants.





- Quarterly meetings with all grant recipients.
- Tony Weber's job is Grant and Legislative Administrator.
- Working through process to amend rule hearing at 777 on January 19, 2022 at 9:00 AM and is open to the public.

- Staffing and materials will be a challenge and IDVA is covering extra 30% costs associated with it. It will need to be done by September.
- Chairman Steuterman expressed concern over level headstones and importance of caring for those that have passed. Level headstones will be addressed with the new system under raise and realign. All of which is complete and paid along with adequate equipment.
- Budget was increased for cemetery which was appropriate and IDVA is spending a bit over. Cemetery is purchasing what is needed and provided a time scale on the life of the equipment.

# Richard Leirer, Legislative Update

- Most goals for Big 4 will not come to fruition.
- Income reduction for property tax.
- Tuition & Fee exempt considered for spouse of 100% disabled vet.
- Dir. Wimer discusses evaluation of impact of adjustment of tuition and fee exempt program and how IDVA is working with CHE/MPH to review data and provide analysis.
- American Legion is pushing free admission to state parks for veterans, which has not made it onto bill. National Parks currently offers free admission to veterans.
- VFW Service Office is now fully staffed and is getting positive reviews.

Mayor Snow, Welcome to Richmond

• The morning started with a tour of Cronin Toyota. It was followed by a tour of the Veterans Memorial Park.

Review of Veteran Services/Programming in Richmond, Indiana

- Wayne County Veteran Service Officer spoke about working in Wayne County. CVSO
  office is well supported in the community. Cronin Toyota set up a Veterans Assistance
  Fund. The CVSO along with the DAV set up a transportation network to transport
  veterans to appointments at the VA health facilities. This transportation is provided by
  volunteers.
- Director Wimer discussed the purpose of the Commission and IDVA.

Mike Thompson, Military Family Relief Fund Update

- Quarter two consisted of the regular MFRF and a secondary MFRF program during the holidays called Operation Holiday Program.
- 732 MFRF applications received in 2021.





- Mr. Coley discussed the MFRF Taskforce Concerning MFRF Matters.
- The Commissioners on the Taskforce review over \$2,500 requests, income waivers, and Other Than Honorable discharges, and non-final orders from the administrative law judge.
- 45 applications approved by taskforce, 16 were over the \$2,500 amount.

# Joe Devito, MFRF Outreach Plan Update

- Last quarter we are into text messaging. It is an opportunity to communicate with the veteran community. We had close to 20,000 pieces of data and that was scrubbed to get the info we needed. It is all now in one spot. Interactive system for veterans to find info.
- Text the word VET to IDVA, this gives us the opportunity to get information out to you.
- One of the things we are targeting is nonprofits that help veterans.
- We want to direct veterans to their CVSO's.

# Gabrielle J. Owens, Grants for Veterans' Services

- Eleven awards have been granted.
- \$484,000.00 has been granted out. Indiana code sets out what grants can be used for homelessness, therapeutic services, finding employment, legal services, guardianships.
- Grant program runs on the state fiscal year. We are currently in quarter 3. Reach veteran services as already expended all of their funds. There are 2 that have not expended any of their funds. IDVA has reached out to meet with them to see what we can do to help them spend those funds.
- GVS program is governed by the Indiana Code and we identified some changes we would like to implement. The rule is currently with the Attorney General's office. As soon as we hear back from them, we will update the commissioners. We are looking to put out on Monday the solicitation for the 2023 GVS program. First year we had 20 applications. The next time we had about 80 applications. We anticipate 100 applications for this cycle. Trying to get the maximum exposure to get as many applications as possible.

# **Public Comment**

- Veteran recent experience at Reid Hospital. Issue with the pharmacy no longer accepting VA insurance.
- Veteran problem with CPAP. Received a letter from the VA. It could be another 6 months before it is resolved.
- Veteran trying to get wife registered with CHAMP. Saying it will take a year.

# Gabrielle Owens, Tuition and Fee Exemption Appeal

- Appeal for Ms. Wrigley- adoption after she was 18. Did not pursue because of COVID concerns. They have health issues that prevented them from wanting the in home visits. After the hearing, IDVA reached out to him to see if he had any evidence of telephone calls with the attorney the petitioner was working with. Earliest phone calls were made 22 days before she was 18 years old.
- Asking the commission if they want to hear it again.
- Gullion recommends to hear the case again.
- DeRue Motion to deny an additional hearing, Caldwell seconds
- Motion passes 4-2.

- Able to get the report down to 20 pages. Consistency on what is being reported year to year.

# Richard Leirer, Legislative Update

- 25 bills written and authored but the Senate had 7, and none of them made it to a committee hearing.
- The house had 18 bills, 2 had a hearing and made it to the Senate, where they died.
- It's a non-budget year and not much happens.

## Tim Dyke, Training and Services Update

- Total of 1412 benefits since January 224 veteran license plates (does not include branch plates), 111 tax, Tuition from last August just under 1,000, 45 Hunting and Fishing.
- 87 county service officers accredited.
- Working with an organization to make sure we are training the CVSO's as well as we can.
- Have a memorandum of agreement with the VFW to have cross accreditation with IDVA. This allows IDVA to look into the veteran benefit system.
- 2 vacancies in the DSO positions. Trying to get them filled before the state hiring freeze.
- CVSO conference will be held in person again this year.





• Claims management system we use was purchased by another company. 86 counties are currently using the system we now have over 157,000 veterans in the system.

Mark Friel, Indiana Veterans Home - Cemetery Update

- Cemetery has been part of the campus since 1896.
- 2989 burials on site.
- There have been 12 burial YTD. Burials are for veterans and their spouses who resided at the home.





• Two grants have been submitted. The first proposal is for headstone raise and realignment. The second proposal is for expansion.

Review of Veteran Services/Programming in and around Lafayette, Indiana

- Jennifer Shook, Development Director of LTCH, homeless services.
- They are one of our GVS grant recipients.
- Work with veterans and their families who are at risk for homelessness or are already homeless.
- Service several counties in and around Tippecanoe County.
- Funded through federal and state.
- Work with other partners to help veterans get quickly connected to services they need.
- Will host a Veterans Stand Down on November 5.

# Mike Thompson, Kevin Coley, Military Family Relief Fund Update

- These are the 4<sup>th</sup> quarter stats- 331 applications submitted, 99 approved, 75 denied and 157 closed out. Total awarded is \$138,208.62
- Housing is the biggest amount paid out to veterans.
- MFRF Taskforce has held 8 meetings since the last commission meeting. Meetings are scheduled for every Friday.

# Gabrielle J. Owens, MFRF Rule Update

- Rule 4 Recommending a deletion of the sentence that talks about the department can only consider an application if it is complete. It is not sensible to the operation of the program or the veteran. No need to complete the form if it can be determined they are not eligible from what they have already turned in.
- Rule 5 Application Procedures. Strike the part where it says the veteran needed to be involved in a conflict or war. Suggesting language that says if currently serving or has leave and earning statements, those could be used as proof.
- Section 2 currently says the department will reach out to the veteran in writing. From an administrative process it slows down the application.
- Any guidelines the commission wants to put in the rules should there be a hard limit?
- Section about short duration programs. We have OHP and BTS. Department will determined based on available money and veteran need.
- Three Recommendations
  - o Recommendation one Any IDVA staff member that applies for the MFRF program has to go through the commission





- Recommendation two How do we as the department manage the applicants that will go over \$2,500 when they can apply year after year for the short term programs?
- Recommendation three Those who have received regular MFRF money.
   Veterans who have applied and received \$2,500 and those who have applied six or seven times. Still have the taskforce review those.
- Leirer motion to approve the three recommendations, Caldwell seconds. Motion passed 7-0

# Dennis A. Wimer, MFRF Outreach Update

- Can spend up to 10% of MFRF money on outreach.
- Doubled the expenditures.
- In the first quarter of this year we are at the \$600,000 mark.

# Gabrielle J. Owens, Grants for Veterans' Services

- The end of FY22, close out of the previous fiscal year.
- Some of the grantees did not spend 100% of their money. That money was pulled over to the current fiscal year. Currently 14 grantees were awarded \$680,000 from the previous unspent funds.
- There was a gap where there were no submissions from out grantees. All were received by the June 30<sup>th</sup> deadline.

  - Second Bill Agency Bill 1017 There are a couple of key components 1) added IVH as a state cemetery 2) getting rid of the wording for SAA saying all employees have to be veterans.





- Third Bill Can ask for \$2500 amount for MFRF. Take out the sentence that says "one time".
- Fourth Bill Any excess funds go to the MFRF Trust Fund. It is up to around \$11M. Would like to set a base around 1M to 2M. Want to put the funds back out into the community.
