County Revised Guidance on Appointing Signature Designee(s)

Purpose

The Indiana Department of Workforce Development (DWD) is revising the protocol and notification process for Indiana's eleven Regional Workforce Board Chairs and for the Workforce Investment Board of Marion County Chair to appoint a designee(s) to sign grants and contracts concerning Indiana's Workforce Investment System. To receive this funding, each Regional Workforce Board and the Workforce Investment Board for Marion County must be a recognized legal entity.

Rescission

DWD Communication 2005-07, dated December 9, 2005, and entitled, *Authorized Signature and Depository Records*.

DWD Policy 2005-27, dated June 15, 2006, and entitled, *Required Workforce Investment Board and Regional Workforce Board Incorporation to Receive Funding as of July 1, 2006*.

Content

The Chairs of Indiana's eleven Regional Workforce Boards shall notify the Indiana Department of Workforce Development's Director of Budget and Accounting in writing when a change is to be made to any authorized designee. The Chair should explain in the letter which types of grants and contracts the designee may sign. For Marion County, the Chair of the Workforce Investment Board and the Chief Elected Official shall determine the designee(s) together. A letter appointing their designee(s) shall be co-signed and sent to DWD's Director of Budget and Accounting when the designee(s) changes. They should explain in the letter which types of grants and contracts the designee may sign concerning Indiana's Workforce Investment System. A form to assign an authorized designee is no longer required.
