



Re: Worker Adjustment and Retraining Notification Act ("WARN") Notice

Dear Sir or Madam:

Over the last several months, Evergreen Recreational Vehicles, LLC ("Evergreen RV") has been actively seeking capital or business to continue its operations. In particular, Evergreen RV has been engaged in negotiations with various creditors and lenders seeking financing or refinancing through the arrangement of loans and other methods of internally generated financing, as well as seeking additional money, credit or business through various commercial reasonable methods. Despite Evergreen RV's commercially reasonable efforts, Evergreen RV has been unable to obtain the necessary financing or business to continue its operations.

Accordingly, pursuant to WARN, this notice is to inform you that Evergreen RV will be permanently closing its facilities located at 10758 County Road 2, Middlebury, Indiana 46540 and 51700 Lovejoy Drive, Middlebury, Indiana 46540. The permanent closure of the above-mentioned facilities will affect approximately 270 employees. Evergreen RV began eliminating positions on June 10, 2016 and will continue in phases until complete closure of the above-mentioned facilities on or about June 24, 2016. No employees of Evergreen RV are represented by a union. Bumping rights do not exist. A list of the job titles of affected positions, the number of affected employees in each job classification, and the anticipated scheduled for such employment separations is enclosed as **Exhibit A**.
