



Re: Depot Closure - WARN Notice

Dear Ms. Long:

This notice is being provided pursuant to the Worker Adjustment and Retraining Notification Act of 1988, which requires employers to give official notice to certain government units or officials of a pending facility shutdown.

This notice is a follow-up to the notice sent on December 16, 2009.

On December 21, 2009, (2) NECDF Nurses, (1) NECDF Medical Records Technician (4) NECDF Paramedics terminated.

On December 29, 2009 (1) Captain (1) Lead Officer (7) Firefighter I (1) Medical Technologist (5) Security Officers terminated.

On December 30, 2009 (1) Fire Inspector (3) Captains (7) Firefighter I (1) Chemical Operator (1) Lead Chemical Operator (1) Material Handler (6) Security Officers and (1) NECDF Tool Room Lead terminated.

On January 11, 2010 (1) NECDF Clinic Administrator, (1) PA/FNP, (1) NECDF Paramedic and (1) NECDF Security Officer terminated.

On May 3, 2010 (73) Newport Chemical Depot NECD employees were notified that Mason & Hanger Corporation final contract with the Army ends July 18, 2010 and the entire facility may be closed sometime in the near future. There are no applicable bumping or transfer rights.
