



Re: Announcement of Planned Action

Dear Ms. Long:

We are writing to give you notice that Springleaf Finance and its affiliates will be closing its Mortgage Servicing Operations (a/k/a Evansville Service Center) facility located at its headquarters office at 600 NW Second Street, in Evansville, Indiana on or about September 30, 2014. This closure is expected to be permanent and will result in the layoff of all employees in that business operation, who are not placed in open positions within the company.

All affected employees have been notified of their separation dates and that their separation from employment will be permanent. Those employees are expected to be separated from employment on October 5, 2014.

The attached is a list of the job positions and number of individuals who will be affected by the closure and layoff.

There will not be any bumping rights for the affected employees; that is, employees will not be able to displace more junior employees out of their job positions as a result of this closure/layoff. However, impacted employees are eligible to apply for any open positions with the company.
