#### **Welcome and Introductions**

Cory Best, ICC Chair, called the meeting to order and welcomed everyone. All ICC members were asked to briefly introduce themselves, both in person and virtually.

No family story was available today.

#### **Approval of October 2024 Minutes**

A request was made by Dr. Megan Purcell to make an alteration in the Council Member Collaboration section, clarifying a resource she shared at the October meeting.

Cory Best asked for a motion to approve the October meeting minutes as amended. Mariann Frigo made a motion to accept the meeting minutes as written. Courtney Willis seconded the motion, and a vote was taken, with all members approving the motion. The motion was carried.

#### **Early Childhood Spotlight:**

Christina Commons shared that this agenda item will begin at the May 2025 meeting and thereafter. The purpose of this agenda item is to focus on engaging local programs and increasing access to resources to children with disabilities. The aim



is to invite speakers to share initiatives and engage partners in discussions. Christina requested that any spotlight suggestions are sent to Megan Hershey.

### **State First Steps Update:**

Christina Commons, First Steps Director, shared recent First Steps staffing updates. She presented the number of children receiving at least one IFSP service between 7/1/23 and 6/3/24 (26,614 children).

The Indiana Early Intervention Conference will be held on June 12-13, 2025. First Steps is still seeking proposals. More information can be found here: https://earlyintervention.iu.edu/index.html

Christina Commons and Janet Ballard, Research Associate with IU Early Childhood Center, presented on the Indiana's Part C Annual Performance Report for FY2023 (see Power Point). A breakdown of all compliance indicators and results were presented. Janet Ballard emphasized the importance of the Child and Family Outcomes, which were met or exceeded in most cases. Christina Commons acknowledged the hard work of local programs and partners in improving the program's performance and expressed hope for further improvements in the coming years. February 3rd is the deadline to submit the APR to the Office of Special Education Programs.

  - a) Erica Deathe reported no new updates.
- 2) Technology:
  - a) Jason Berty reported no new updates since October 2024. The group continues to brainstorm new technology solutions.
- 3) Other State Systems:
  - a) Jennifer Owens reported that this committee recently met with Katie Herron (Director, Early Childhood Center, Indiana University) who shared IU's website for their tiered technical assistance. Jennifer reported that Janet Ballard will take a new role as the coordinator for this project.

#### **May Strategy Session:**

Cory Best reported that the next Strategic Planning Session will be held in May 2025. The Council approved the 2025 ICC meeting dates which will include a shortened meeting in May to allow for the Strategic Planning Session for ICC members only. This strategy session will focus on how to improve the ICC and the strategic direction for the next 3-5 years. Christina Commons added that if the Council needs any specific state data before the May session, please make your request as soon as possible. Council members should consider ideas and topics for the upcoming strategy session in May and share them with Megan Hershey.
