- II. Approval of the March 14, 2025, meeting minutes
  - a) The Commission voted unanimously in favor
- III. Public Comment
  - a) There were no members of the public who made comment
- IV. BRS Director's Update Theresa Koleszar
  - a) Updates from March Meeting
    - Bylaws submitted for posting on VR Commission page of BRS website sent to membership via email
    - CSNA finalized and submitted for posting on VR website link forthcoming
    - Customer Satisfaction Committee update will be provided at September meeting
    - Federal fiscal year 2025 final VR grant funding was received in April (continuing resolution), reflecting an increased award over prior year however state match would be needed to draw the additional federal funds
    - Establishment projects remain on track to begin July 1, 2025
  - b) VR Updates from FSSA Quarterly Financial Review
    - BRS Program Metrics Enrollment
      - 1. 1,659 VR applicants in SFY25 Q3; 4,677 YTD
      - 2. 14,082 open VR cases/individuals served in SFY25 Q3; 16,866 YTD



- 3. 1,321 VR cases closed in SFY25 Q3; 4,105 YTD
- 4. 552/1,321 (42%) of VR closures exiting with employment in SFY25 Q3; 1,384/4,105 (34%) YTD
- BRS Program Metrics Outcomes
  - 1. 82% of BEP sites operated by blind vendors in SFY25 Q3 and YTD
  - 299 Indiana Interpreter Certifications issued by DHHS in SFY2025 YTD; 4 issued in SFY25 Q3
  - 3. Annual VR spend per case SFY25 YTD \$2,579 (will increase as SFY progresses)
  - 4. 1,384 total VR exits in Competitive Integrated Employment SFY25 YTD; 552 in SFY25 Q3
  - 5. VR waiting list was reduced to 0 in October 2024
  - 6. SFY24 aggregate annual earnings: VR participants exiting with employment and retaining employment one year after exit: \$23,963,352
  - 7. In CY24, 267 VR participants receiving SSI/SSDI achieved employment earnings meeting SSA thresholds for reduction/elimination of cash benefits
- VR Client Service Spend Breakout SFY2025 YTD
  - 1. Highlights: Employment Services ~\$18M, Pre-Employment Transition Services \$8M, Postsecondary ~\$5M
  - 2. Employment Services and Pre-ETS account for almost half of client service spend
- c) VR Participants breakdown from CSNA (SFY22-SFY24)
  - Almost 4/5 eligible individuals have a most significant disability
  - More than 1/3 have a primary impairment of Intellectual/Developmental disability
  - Mental health is most common type of disability when factoring primary and secondary impairment
