- c) Impact of COVID 19 employment status questionnaires
 - Better understand impact of pandemic on employment of VR participants
 - Identify individual needs, e.g. support with adapting to new employer protocols, finding new employment, etc.
 - Summary of results so far...
 - o As of July 31, 2020, 665 questionnaires completed
 - 16% reported laid off, 40% furlough, 2% remote work due to COVID – 19
 - o 4% reported terminated for other reasons, and 11% quit working
 - o Only 1/3 reported no impact on employment due to COVID 19
