### Welcome and Introductions

Cory Best, ICC Vice-Chair, called the meeting to order at 10:10am and welcomed everyone. A family story was shared via video from Dominique Franklin. She is a mom of twins who received services through First Steps and shared her experience.

## Approval of May 2023 minutes

Cory Best asked for a motion to approve the May meeting minutes. Megan Purcell made a motion to accept the meeting minutes as written. Mariann Frigo seconded the motion, and a vote was taken:

13 members approved and 2 members abstained. The motion was carried.

### First Steps and IN EI Hub Update

Christina Commons, First Steps Director, gave a brief update on what has happened in the program since May. She shared a summary of the 2023 Indiana Early Intervention Conference that took place in June, the State's OSEP Determination, and the First Steps office current priorities. # **Sub-Committee Summary Advocacy:**

Jason Berty with the assistance of Hannah Carlock gave the summary. The group discussed service coordination caseload size with a lot of questions around how they are serving families. They also discussed the need of consistent training across the System Points of Entry (SPOE). A question they would like to answer is if service coordinators feel supported in their jobs around resources.



### Fiscal:

Colleen Wasseman gave the fiscal summary. This group discussed what data is available through EIHub that agencies/SPOEs can access. They would like to find out what data agencies/SPOEs are collecting on their own. They would like to see the creation of a pre and post test for potential providers in higher education and for new providers upon hire and after being enrolled and providing services after 6 months.

### PD/ Child Assessment:

Megan Purcell gave the summary. This group is working on child assessment research. The focus is looking at popular child assessment tools to see if they are a good fit for Indiana to determine eligibility. This group met prior to this meeting to look at a rubric of the tools the committee might be interested in recommending to the First Steps office. The following tools were researched:

Bayley-4

Battelle-3

DAYC-2

Early LAP

**HELP** 

IDA

Most of the time was used to discuss and compare the AEPS-3 and HELP.
