The Bureau of Disabilities Services mission is "To connect people with disabilities and their families to resources and supports to live their best life." In support of this mission, BDS is committed to supporting our provider network in working toward a true person-centered system. We believe that professional development strengthens our network as a whole and ensures quality supports for individuals receiving home-and community-based services.

As part of that commitment, BDS is continuing to host a series of web-based training opportunities. These opportunities are being provided at no cost to participants and are **mandatory** for all approved Bureau of Disabilities Services Home and Community-based services providers. This means if your organization is currently approved as a BDS HCBS service provider of *any* HCBS service, an executive level staff member of your organization is required to attend these trainings.

Sign-up, participation and completion of these trainings will be tracked and monitored throughout the trainings.

These trainings will occur on a bi-monthly, regular, set schedule:

- First Thursday of the month at 10 a.m. ET
- Third Tuesday of the month at 1 p.m. ET
- Recording, with live Q&A, last Wednesday of the month at 10 a.m. ET
