1. Updates
 - a. Numbers:
 - i. Enrolled: 13,728
 - ii. Total Client Spending for 2017 FY: \$11,910,791
2. WITS Reminder:
 - a. Please remember that ALL vouchers must end on 6/30/17 as we finish out the 2017 State Fiscal Year (SFY). You may open new vouchers for all clients beginning 7/1/17 or later, as they will be attached to the 2018 SFY. Please let us know if you have questions about this.
 - b. You will find last month's webinar and a recent memo included with these minutes as a reminder of how the billing process works, and information that is needed when making WITS requests.
 - c. In addition, if you are requesting additional funding for a client, either for a particular service or over cap, please include the information requested and answer the following four questions:
 - i. What has prohibited the client from getting connect to benefits so that Recovery Works funding is not necessary? What is the plan to get the client connected to benefits in order to no longer need RW funding?
 - ii. How many total dollars are needed over the next 30 days? 60 days? Please include the exact service, number of units, and total dollar amount.
 - iii. What is the client's level of need that justifies additional funding? Why is it clinically necessary for the client to receive the services listed above?
 - iv. How will this assist the client in their recovery?



- d. Starting July 1, 2017, we will no longer accept requests unless ALL of the necessary information is present. This is in order to serve you better and more efficiently.
 - e. We greatly appreciate your compliance and assistance in these requests.
3. Questionnaire:
- a. As many of you know, treating those with Opioid addiction can be very difficult and is beginning to show a higher sign of relapse in a shorter period of time. In order to share the wealth of knowledge in our efforts to fight the current epidemic, I have a few questions that I would love to hear back from you on:
 - i. Are you providing any Opioid specific programing? (ie groups that require a Opioid use diagnosis)
 - ii. Are they working?
 - iii. Would you be willing to share the curriculum that you are utilizing?
 - iv. If not anything specific, have you seen anything that is being successful at this point?
