INTRODUCTION

The Annual Synar Report (ASR) format provides the means for states to comply with the reporting provisions of the Public Health Service Act (42 U.S.C. 300x-26) and the Tobacco Regulation for the Substance Abuse Prevention and Treatment Block Grant (SABG) (45 C.F.R. 96.130 (e)).

How the Synar report helps the Center for Substance Abuse Prevention

In accordance with the tobacco regulations, states are required to provide detailed information on progress made in enforcing youth and young adult tobacco access laws (FFY 2023 Compliance Progress) and future plans to ensure compliance with the Synar requirements to reduce youth and young adult tobacco access rates (FFY 2024 Intended Use Plan). These data are required by 42 U.S.C. 300x-26 and will be used by the Secretary to evaluate state compliance with the statute. Part of the mission of the Center for Substance Abuse Prevention (CSAP) is to assist states¹ by supporting Synar activities and providing technical assistance helpful in determining the type of enforcement measures and control strategies that are most effective. This information is helpful to CSAP in improving technical assistance resources and expertise on enforcement efforts and tobacco control program support activities, including state Synar program support services, through an enhanced technical assistance program involving conferences and workshops, development of training materials and guidance documents, and onsite technical assistance consultation.

How the Synar report can help states

The information gathered for the Synar report can help states describe and analyze substate needs for program enhancements. These data can also be used to report to the state legislature and other state and local organizations on progress made to date in enforcing youth and young adult tobacco access laws when aggregated statistical data from state Synar reports can demonstrate to the Secretary the national progress in reducing youth and young adult tobacco access problems. This information will also provide Congress with a better understanding of state progress in implementing Synar, including state difficulties and successes in enforcing retailer compliance

with youth and young adult tobacco access laws.

Where and when to submit the Synar report

The ASR must be received by SAMHSA no later than December 31, 2023 and must be submitted in the format specified by these instructions. Use of the approved format will avoid delays in the review and approval process. The chief executive officer (or an authorized designee) of the applicant organization must sign page one of the ASR certifying that the state has complied with all reporting requirements.

The state must upload one copy of the ASR using the online WebBGAS (Block Grant Application System). In addition, the following items must be uploaded to WebBGAS:

- FFY 2024 Synar Survey Results: States that use the Synar Survey Estimation System (SSES) must upload one copy of SSES Tables 1–8 (in Excel) to WebBGAS. Please note that, in the FFY 2024 ASR, SSES will generate Tables 6, 7, and 8, which are based on the optional microdata on product type, retail outlet type, and whether identification was requested. If your state does not submit these optional data, Tables 6, 7, and 8 will be blank. Tables 6, 7, and 8 are generated for the convenience of the state, and states are not required to submit completed versions of Tables 6, 7, or 8. States that do not use SSES must upload one copy of ASR Forms 1, 4, and 5, and Forms 2 and 3, if applicable, (in Excel), as well as a database with the raw inspection data to WebBGAS.
- Synar Inspection Form: States must upload one blank copy of the inspection form used to record the result of each Synar inspection.
- Synar Inspection Protocol: States must upload a copy of the protocol used to train inspection teams on conducting and reporting the results of the Synar inspections. This document should be different than the Appendix C attached to the Annual Synar Report.
- A scanned copy of the signed Funding Agreements/Certifications

	Merchant education and/or training
	Indiana was able to create a state specific online retailer training that launched in Oct. 2021. 14 training certificates were issued in FFY23. There is an e-newsletter that is being sent quarterly to a list of now over 1,000 retailers. This newsletter includes information on properly checking IDs, resources available to retailers, and other topics of interest to Indiana retailers. We have issued 3 retailer newsletters so far this year with an average open rate of 29% and the subscription list started at 110 subscribers and currently is at 3,227.

	There is a map of retail locations similar to that of the FDA map that includes all inspections done in the state starting June 2019. This will help better equip communities and shop owners with locating those retailers in specific areas and their most recent compliance information. 	The plan to reduce the State of Indiana's current RVR of 11.9% is as follows: We will work more closely with retailers' groups and utilize the listsery of tobacco retailers to continue the quarterly newsletters with important information about retailer compliance with tobacco age of sale laws and resources. We will continue to promote the use of the online tobacco retailer training for clerks and attempt to do more regular mailings about this training to retailers. We also plan to continue direct outreach and recognition of those retailers who are in compliance with the law as well as offer technical assistance to those who violate.

The current SSES program only works on much older versions of Windows. We currently keep a very dated computer just to run our Synar report. This eventually will no longer be a viable option if this computer stops working. We would love to have a copy of the SSES that works on the operating systems that are available currently. If the current SSES stops working it would be a significant cost to the state in order to process the data collected and get an approved methodology on file with SAMHSA. We have been trying to find ways to work around this with our state IT staff but have not been able to determine a solution to allow the SSES software to work on newer devices.

Synar inspection teams are made up of an inspection officer (police officer), a chaperone (who must be an adult and is usually an additional excise police officer), and the youth inspector. The youth remain in the vehicle with the chaperone when the officer enters the store. The chaperone them observes the youth as they enter the store at which point, they are under the observation of the officer. The chaperone continues to monitor the area outside the store until the youth exits, at which time they are under the observation of the chaperone until the officer returns to the vehicle. The youth is always under the direct observation of one or both adult members of the inspection team.

Given the public health issues that surfaced related to COVID-19, Indiana will allow the use of face coverings per guidance, policy, or law from state or county officials for current or future public health issues that would require such protocols. Indiana will also comply with any individual retail establishment requirements for face coverings due to public health crisis and/or pandemic. We will however ask and/or supply those doing inspections with a solid-colored mask free of any pattern or logo that may or may not indicate the age of the youth. Indiana would also like to reserve the ability to exclude specific counties from the Synar sample if recent data indicates too much of a risk for the safety of both the youth and officers conducting the inspections.
