RE: Upcoming Renewal of the 1915(b)(4) Waiver for Adult Mental Health Habilitation and Behavioral & Primary Healthcare Coordination Programs.

Dear Director Gatties:

The Indiana Family and Social Services Administration (FSSA) Office of Medicaid Policy and Planning (OMPP) intends to renew the 1915(b)(4) waiver for selective contracting of the Adult Mental Health Habilitation (AMHH) and Behavioral & Primary Healthcare Coordination (BPHC) programs. This waiver allows for selective contracting with Community Mental Health Centers to be the only providers of services for these programs. No substantive changes are being made to the waiver currently.

In addition to the waiver renewal, the OMPP is making available for comment an independent assessment of the waiver that was conducted by Wellbeing Informed by Science and Evidence (WISE) Indiana. The purpose of the assessment is to evaluate the quality of care, access to care, and cost-effectiveness of the AMHH and BPHC programs. The waiver renewal will have an effective date of December 1, 2024.

The 1915(b)(4) renewal and independent assessment will be available for review and comment on the DMHA-Adult Draft Policies for Public Comment webpage (https://www.in.gov/fssa/dmha/Public-Comment) on or before July 3, 2024. Notice of Renewal of 1915(b)(4) Waiver for Selective Contracting for Adult Mental Health Habilitation (AMHH) and Behavioral and Primary Healthcare Coordination (BPHC) Programs

Per public notice requirements established at 42 CFR 447.205, the Indiana Family and Social Services Administration (FSSA), Office of Medicaid Policy and Planning (OMPP) publishes this notice to renew the 1915(b)(4) waiver that allows for selective contracting of Community Mental Health Centers for the AMHH and BPHC programs. The public comment period will run from July 3rd, 2024 through August 2nd, 2024.

The Family and Social Services Administration (FSSA) – OMPP proposes to renew the 1915(b)(4) waiver for an additional five years. No substantive changes are being made to the waiver currently. In addition to the waiver renewal, the OMPP is making available for public comment an independent assessment of the waiver that was conducted by Wellbeing Informed by Science and Evidence (WISE) Indiana. The purpose of the assessment is to evaluate the quality of care, access to care, and cost-effectiveness of the AMHH and BPHC programs. This waiver amendment will have an effective date of December 1, 2024.
