## Overview

The Child Care and Development Fund (CCDF) program provides resources to state, territory, and tribal grantees that enable low-income parents to work or pursue education and training so that they can better support their families while at the same time promoting the learning and development of their children. The CCDF program also provides funding to enhance the quality of child care for all children. The CCDF Plan is how states and territories apply for CCDF funding and is the primary mechanism that the Administration for Children and Families (ACF) uses to determine state and territory compliance with the requirements of the law and rule (98.16).

This plan describes and provides assurances regarding the CCDF Program to be administered by the state for the period 10/1/2025 to 9/30/2027. This plan will be effective after approval from the Office of Child Care.
