Medicaid Assistance Overview

March 2025 YTD Financial Results

Basis for Comparison

- Year to Date results for State Fiscal Year 2025 (July 1, 2024 March 31, 2025) are being compared to the December 20204 Medicaid Forecast
- The next Financial Review Meeting will feature results through June 30, 2025 and will compare those results to the April 20205 Medicaid Forecast

Overall Results

- Overall average Year to Date enrollment was 32,531 (1.6%) less than Forecast
- Year to Date Medicaid expenditures were \$491.3M (3.2%) less than Forecast



- Timing delays for DSH payments are driving the positive variance to forecast
- Areas with YTD expenditures higher than forecast include the Nursing Facility Supplemental Payment program and FQHC Supplemental Payments

Health & Wellness Waiver – Attendant Care




- March 2025 is the fifth month that Attendant Care expenditures have been materially below forecast for the Health and Wellness Waiver


Community Integration and Habilitation (CIH) Waiver – Residential Habilitation Services


Program of All-Inclusive Care for the Elderly (PACE) Enrollment / Expenditures




- PACE enrollment has continued to grow at a rate higher than projected in the Dec 2024 forecast
- Growth rate may be related to the wait list for the PathWays waiver program.
- PACE expenditures also grow at a rate higher than projected in the Dec 2024 forecast
- Expenditures for September 2024 include retroactive adjustments made following MS rate approval

Applied Behavior Analysis (ABA) Therapy





- The Managed Care Programs are seeing continued 20% growth in the number of ABA Therapy recipients
- The State FFS program is seeing a small decrease in the number of ABA Therapy recipients
- Managed Care Expenditures are showing an increase in ABA expenditures, but at a lower rate than the recipient growth
- FFS expenditures are showing a slight downward trend

Medicaid Administration Overview (1/4)

Medicaid administrative costs represent a relatively small portion of total Medicaid spending (>1% for OMPP).

In general, costs incurred by states in administering the Medicaid program are matched by the federal government at a 50 percent rate. There are, however, some types of administrative functions which are matched at higher rates.

90% Federal Match

Claims and Eligibility System Design, Development and Implementation

Medicaid Administration Overview (2/4)

Medicaid Administration includes:

Children's Health Insurance Program Administration (CHIP) - the general operating costs associated with the administration of CHIP.

- CHIP pays for medical services to children in two benefit packages in the Hoosier Healthwise Program. Under Package A, CHIP includes members ages 1-19 up to 158% FPL using Modified Adjusted Gross Income (MAGI) methodology.
- CHIP also pays for medical services for children in Hoosier Healthwise Package C.
 This benefit package covers children birth through age 1 between 208%-250% FPL and ages 1 through 18 between 158% and 250% FPL using Modified Adjusted Gross Income (MAGI) methodology. Families must pay a monthly premium and some small co-payments.

Healthy Indiana Plan Administration (HIP) - the general operating costs associated with the administration of HIP. The plan covers Hoosiers ages 19 to 64 up to 133% FPL with a 5% Modified Adjusted Gross Income (MAGI) who meet specific income requirements.

Medicaid Administration Overview (3/4)


Indiana Prescription Plan/Hoosier Rx - the general operating costs associated with the administration of the Indiana Prescription Drug Program for seniors, more commonly known as Hoosier Rx. Hoosier Rx provides assistance to limited-income seniors, 65 and older, to help pay for their Medicare Part D insurance premium. Current enrollment is 156 individuals.

Medicaid Administration - the general operating costs associated with the administration of Medicaid. Expenditures include organizational operating and clerical costs associated with the implementation of the State's Medicaid Program.



Note: March Contract spend. Contracts spend is coming in less than projected. Average monthly contract spend was projected to be at \$12.8M. The variance is driven by a lag in vendor invoicing due to contract amendments and a realignment of expenditures, moving spend for the Medicaid Admin bucket to the now ended Home and Community Based Services funding provided by Section 9817 of the American Rescue Plan Act. While we show a \$16M forecasted balance in contract spend, that is federal funding and not State.
