

# **Indiana Overarching Goals**

## State-Level Initiatives

- Statewide investments in data and technology to improve access to services and information (Freedom and Opportunity Agenda)
- Allows economies of scale for large budget projects
- Workforce initiatives that are not unique to the region
- Necessary statewide quality improvement
- Able to move fast to invest first year dollars

# **Regional Grants**

- · Mirrors concept of RHTP
- Must demonstrate collaboration among hospitals and systems, FQHCs, CBOs, CHCs, mental health providers etc.
- Must demonstrate that they are minimizing duplication of services and filling gaps.
- Required component to provide services to community agnostic to the provider
- Leads to innovation in addressing non-medical drivers of health
- Does not force unnecessary state initiatives for local problems

# Make Rural America Healthy Again

Improving rural health through prevention, prenatal care, and hospital support

### IN Goal: Empower Rural Indiana Regions to Drive Community-Specific Solutions

#### Make Rural Indiana Healthy Again Regional Grants

Plan to award competitive, regional grants for each of our 8 rural regions, targeting: rural health innovations, new access points to promote preventive health, outcomes-driven chronic disease prevention and management, a trained and ready rural workforce, and tech innovations. Regional organizations will be required to collaborate and form consortiums to qualify.

#### **IN Goal: Meet Indiana Rural Families Where They Are**

#### **Pediatric & Obstetric Readiness in Rural Emergency Departments**

Require statewide pediatric and OB readiness across Indiana's emergency departments, with targeted grants for rural facilities to achieve readiness designation, including EMS readiness.

#### Implementation of Cardiometabolic Health Standards of Care in Rural Indiana

Require all 8 rural regions, with one implementation site per region, to participate in implementation of rural collaborative cardiometabolic care model focused on metabolic risk factors.





# **Sustainable Access**

Improving rural health access through equipment, training, and care coordination.

## **IN Goal: Connect Disparate Systems to Centralize Care Coordination**

#### **Statewide MOCC**

Establish a statewide Medical Operations Coordination Center (MOCC) as a centralized 24/7 hub for day-to-day hospital operational reporting, patient transfer coordination, and EMS resource alignment.

## **Indiana Community Connections**

Implement a statewide coordinated referral network, building upon Indiana 211 statewide community resources to bring clinicians and CBOs into a closed-referral loop.



# **Workforce Development**

Expanding rural health workforce through training, recruitment, and community support.

#### **IN Goal: Grow Indiana Rural Workforce**

## **Strengthening the Rural Health Paraprofessional Workforce**

Centralize coordination of statewide Community Health Worker certification and training curriculum, including lifestyle health coaching.

### **Clinical Training and Readiness**

Expand the rural clinical workforce through preceptorships, Graduate Medical Education programs, and student loan repayment.

#### **Grow Our Behavioral Health Workforce**

Enhance the rural behavioral and mental health workforce through targeted trainings, and college and university high school partnerships.





## **Innovative Care**

Expanding rural health access through innovative, coordinated care solutions.

## **IN Goal: Meet Indiana Rural Families Where They Are**

## Alleviating Access Barriers with Indiana Meds to Beds

Implement predischarge medication delivery programs to prevent delay in prescription pick-up.

Improve Specialty Provider Access through Expanded Tele-Consult Capabilities Expand provider-to-provider consultation availability to Indiana's rural inpatient providers to grow rural access to specialty care.



# **Tech Innovation**

Empowering Hoosiers with digital access to better health.

## **IN Goal: Meet Indiana Rural Families Where They Are**

#### **Tele-Health**

Expand patient-to-provider remote consultation, including targeted expansion of telehealth for women and pregnant mothers.

## **IN Goal: Connect Disparate Systems to Centralize Care Coordination**

## **Medical Interoperability**

Improve the current landscape of rural health IT infrastructure, targeting interoperability of rural health information exchange, behavioral health data, and mobile integrated health. Integrate nutrition incentives directly onto SNAP EBT and improve cybersecurity.
