EXECUTIVE ORDER _____25-56

MAKING INDIANA HEALTHY AGAIN BY INCREASING CONSUMER TRANSPARENCY RELATED TO FOOD DYES AND ADDITIVES

TO ALL WHOM THESE PRESENTS MAY COME, GREETINGS.

- WHEREAS, the State of Indiana is committed to protecting the health and well-being of all Hoosiers, particularly our children, by ensuring the safety of food products available within the state;
- WHEREAS, as indicated by the U.S. Food and Drug Administration ("FDA") revoking the authorization of FD&C Red No. 3, scientific research has indicated potential adverse health effects associated with certain artificial food dyes;
- WHEREAS, many Hoosiers experience adverse reactions to certain food dyes, including headaches, hives, and other symptoms that impact their quality of life;
- WHEREAS, certain food dyes can trigger allergic reactions in sensitive individuals;
- WHEREAS, Hoosier parents have expressed growing concerns about limiting their children's exposure to artificial additives in food products;
- WHEREAS, many Hoosiers have expressed a desire for greater food transparency, preferring to know exactly what ingredients are in their food and opting for products with fewer artificial ingredients; and
- WHEREAS, the State of Indiana should take proactive measures to assess and address potential health concerns related to specific artificial food dyes and additives that may pose health risks to Hoosiers;

NOW, THEREFORE, I, MIKE BRAUN, by virtue of the authority vested in me as the Governor of the State of Indiana, do hereby order that:

- 1. The Indiana Department of Health ("IDOH") shall conduct a comprehensive assessment on the health impacts of artificial food dyes and additives, prioritizing those which have been identified by the federal government or other states to be harmful (including FD&C Red No. 40, FD&C Yellow No. 5, FD&C Yellow No. 6, FD&C Blue No. 1, FD&C Blue No. 2, and FD&C Green No. 3).
- 2. In conducting its assessment, IDOH shall:
 - a. Evaluate existing scientific research on these artificial food dyes and additives;
 - b. Assess their prevalence in food products commonly consumed by Hoosiers, and identify potential health risks associated with their consumption; and
 - c. Consult with the FDA, medical professionals, public health experts, food safety specialists, and consumer advocates.
- 3. Upon completion of its assessment, and no later than July 1, 2026, IDOH shall submit to the Governor a written report including, for each artificial food dye and additive identified for assessment, information related to:

 Potential adverse health impacts associated with the artificial food dye or additive; b. High-risk population groups that are most susceptible to the adverse effects identified by this report;c. The effectiveness of existing state and federal regulations in mitigating the adverse health impacts identified by this report; andd. Recommendations for implementing appropriate restrictions or bans on

harmful artificial food dyes and additives in the State of Indiana.

4. Upon completion of its assessment, IDOH shall also develop a public education campaign to inform Hoosiers about the potential risks associated with any artificial food dye or additive identified to be harmful and alternatives available to consumers.
