Governor Braun,

Transparency for State affiliated foundations has been a priority for your administration, as laid out in Executive Order 25-43. As you are aware, several State affiliated foundations exist and operate as extensions of an affiliated Indiana State Government entity.

Certain State affiliated foundations have previously operated with legal exemptions to Form 990 filings. The completion of IRS return filings for State affiliated foundations is a key step in ensuring that Hoosiers can access information regarding salaries, partnership, activities, and financial conditions of the State affiliated foundations. Pursuant Executive Order 25-43, State affiliated foundations were required to verify their submission of IRS 990 returns and make those documents accessible.

I am happy to share the enclosed certifications of compliance from various State affiliated foundations in compliance with Executive Order 25-43. The enclosures represent compliance from eight different State affiliated foundations across a wide spectrum of associated government functions. From benefiting schools to promoting economic development and tourism in the State of Indiana, transparency has increased across the board for the functioning of Government.

On behalf of the Indiana Economic Development Foundation, Inc. (“IEDF”), I certify IEDF’s compliance with Executive Order 25-43, which requires state-affiliated nonprofit entities to file IRS Form 990 returns for the current year and the preceding nine years by December 31, 2025.

IEDF historically operated under an exemption from annual Form 990 filings pursuant to IRS Revenue Procedure 95-48 as a government-affiliated entity. In response to Executive Order 25-43, IEDF prepared and submitted the required filings for the last ten fiscal years and did so in a manner aligned with IRS requirements and system limitations (i.e., electronic filing for the most recent returns and paper filing for earlier years).

For paper-filed returns, IEDF enclosed a cover letter explaining the organization’s historical exemption under Rev. Proc. 95-48 and the rationale for voluntary filing considering Executive Order 25-43. The returns were mailed to the IRS Service Center in Ogden, Utah, with the enclosed explanation.

These filings collectively satisfy the Executive Order’s ten-year requirement. IEDF also provided complete copies of the returns to its Board of Directors prior to submission, consistent with the governance disclosure on Form 990. IEDF further complied with the public disclosure requirements of Executive Order 25-43 by posting the filed returns to the Indiana Economic Development Corporation’s transparency portal.

We appreciate the Administration's commitment to strengthening public trust and ensuring that organizations like ours maintain clear and responsible governance of public and private resources.

I would like to affirm that HHF is in compliance with the following requirements outlined in the Executive Order:

- **IRS Form 990 Filings:** Our IRS Form 990 filings for the past ten (10) years have been completed, submitted on time, and are publicly available on our [website](#) page with the Indiana Department of Health (IDOH). We remain committed to ensuring continued accessibility and transparency in all future filings.
- **Annual Comprehensive Financial Report (ACFR):** As required, HHF has completed and submitted financial statements to the Office of State Comptroller to be included in the Annual Comprehensive Financial Report (ACFR). 

# About HHF

The Healthy Hoosiers Foundation was incorporated in 2014 to support the work of the Indiana Department of Health (IDOH) and their partners. It was established and governed by Indiana Code (IC 16-19-3-30) as a 501(c)(3). It exists solely to advance public health in Indiana.

The Foundation operates under its supervision as a Type I supporting organization. This means the executive branch appoints a majority of HHF's board to ensure alignment and oversight.

## **Key activities:**

- Fundraising and grant management to support public health initiatives not funded through traditional government channels.
- Community partnerships and outreach to amplify IDOH programs.
- Support for priority areas including infant mortality reduction, childhood vaccination, obesity, tobacco use, HIV/AIDS, mental health, food and nutrition, and chronic disease prevention.

# Projects

## INDIANA FEVER PARTNERSHIP

The Healthy Hoosiers Foundation provided support to IDOH's partnership with Fever Basketball, LLC., for the amount of \$31,500 to fund a public health awareness campaign for the MOMs Helpline through IDOH's Division of Maternal and Child Health. Public awareness activities included marketing assets for the Moms Helpline, which were displayed in Fever gametime ads, on the LED screen at center court, in the Fever app, and throughout the concourse during Fever home games.

Partnering with the Indiana Fever provided an unprecedented level of visibility for the helpline. Each activation contributed to an increase in call volume and website visits, ultimately leading to more families accessing resources that improve health outcomes for mothers and babies. Additionally, collaborating with a well-known organization like the Pacers/Fever enhanced relationships with both new and existing referral partners. This partnership bolstered the credibility of the helpline, establishing it as a prominent resource hub for pregnant women and families.

The project period was May 2023 – October 2024.



# Projects

## BREE WILSON SCHOLARSHIP

The Indiana and national tobacco control partners committed to engaging and empowering young people have established the Bree Wilson Youth Advocate of the Year Scholarship in memory of Breanna “Bree” Lynn Wilson. In honoring Bree’s legacy, Campaign for Tobacco-Free Kids, Truth Initiative, and Indiana’s tobacco control partners honor a VOICE Indiana Core Team Leader or VOICE Youth Ambassador with the Youth Advocate of the Year Award.

Each year a VOICE Indiana Youth Ambassador or Core Team Leader will be selected to win the Bree Wilson Youth Advocate of the Year Scholarship for \$1,000, for their hard work, passion and commitment to pursuing sustainable advocacy efforts within the tobacco control movement in the State of Indiana. This annual scholarship recognizes and empowers the next generation of youth advocates and changemakers by awarding a VOICE Indiana Youth Leader who is making a long-lasting difference in their local community through service, leadership, and creative advocacy efforts.

The **2025 Bree Wilson Scholarship** was awarded to Emily Wart from Bartholomew County, and her dedication to tobacco prevention and smoking cessation. She exemplifies leadership, advocacy, and youth empowerment – Emily organized a teen pool party in summer 2024 to raise awareness about tobacco use and its dangers. She has met with local and state legislators to advocate for impactful policies, and she has worked alongside local leaders, including the Mayor of Columbus, to address pressing community issues.



# Projects

## FOOD IS MEDICINE INITIATIVE


The Healthy Hoosiers Foundation was awarded \$998,255 for two years from the Builders Initiative Foundation to support Food is Medicine in collaboration with IDOH's Division of Nutrition and Physical Activity (DNPA). This funding was designated specifically to DNPA to execute the work plan for Food is Medicine coordination, program support for interventions such as Produce Prescription programs and Double Up Indiana, and capacity building to start creating the foundation for Food is Medicine in Indiana. HHF sub granted with IDOH and provides financial, programmatic, and strategic support to the division.

The DNPA and HHF successfully submitted an annual report for the Builder's Initiative and key achievements include:

- Development of the Food is Medicine Team
- Revitalization of the Indiana Nutrition Incentive Network, a centralized hub for statewide implementers to receive technical assistance and resources for Produce Prescription and Double Up Indiana programming.
- Announcement of the Community Health & Nutrition grant, awarded to six organizations to pilot or support continuation of Food is Medicine interventions.
- Additional achievements including building crucial relationships with stakeholders, hired a policy consultant to create a Food is Medicine primer, and contributed to presentations, locally and nationally, bringing visibility to Food is Medicine in Indiana.

In addition to the support from the Builder's Initiative Foundation, the Healthy Hoosiers Foundation received a donation of \$20,000 from the Rockefeller Foundation, solely designated to DNPA. The DNPA plans to use those funds towards the Double Up Indiana program.

The project period for this grant is June 2024 – June 2026 with grant payments made in two installments.
