b. Agency Reports

- i. Commissioner Fred Payne, DWD
 - 1. Kentucky/Indiana (Kentuckiana) Bi-State Plan for Advancing of the Regional Workforce was signed with USDOL representation present.
 - 2. MOUs signed or in process of signing with other state agencies: IEDC, FSSA, DOC with a focus on aligning and engaging agency partners
 - 3. 60% of WorkOne locations co-located in some form co-location is a goal DWD is working toward
 - 4. Summit/Retreat planned for workforce professionals hosted by DWD in October; invitations to go out soon
 - 5. Finishing up business plan for agency
- ii. Commissioner Teresa Lubbers, Commission for Higher Education
 - 1. Discussed the State of Higher Education address focusing on the transition from high school to college.
