AFFECTED PRODUCT: PASTAÄLGAR FULLKORN, elk-shaped wholegrain pasta or PASTAÄLGAR, elk-shaped pasta

SUMMARY: Unclassified Recall; The recall has been initiated because the product may contain soy, which is not declared on the product label.

The recalled products are PASTAÄLGAR FULLKORN, elk-shaped wholegrain pasta and that PASTAÄLGAR, elk-shaped pasta, sold in the IKEA Swedish Food Market. As a precautionary measure, products with all date stamps are recalled.

The products were sold in the IKEA Swedish Food Market and online - nationwide.

SUGGESTED ACTION: Recommend notification of affected parties via phone, fax, or e-mail. Customers allergic to soy or otherwise concerned are welcome to return PASTAÄLGAR FULLKORN and PASTAÄLGAR to the nearest IKEA store for a full refund. 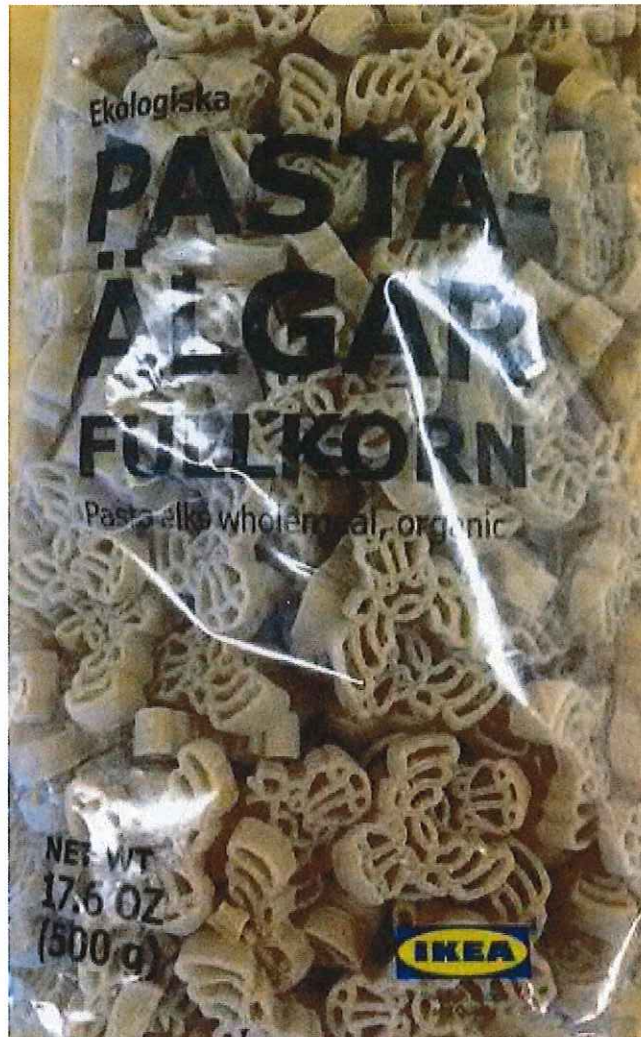
