





FOR IMMEDIATE RELEASE - July 9, 2012 - Sedona Labs today announced that its supplier of Galactooligosaccharide (GOS) has recalled this ingredient due to a possible *Salmonella* contamination. As a result, we are now voluntarily recalling certain lots of our iFlora® Kids Multi-Probiotic® and iFlora™ 4-Kids Powder distributed between 3/16/2011 and 5/3/2012. Salmonella is an organism which can cause serious and sometimes fatal infections in young children, frail or elderly people, and others with weakened immune systems. Healthy persons infected with *Salmonella* often experience fever, diarrhea (which may be bloody), nausea, vomiting and abdominal pain. In rare circumstances, infection with *Salmonella* can result in the organism getting into the bloodstream and producing more severe illnesses such as arterial infections (i.e., infected aneurysms), endocarditis and arthritis.

Customers possessing these products should immediately discontinue their use. To date, no illnesses have been reported in connection with the iFlora® Kids Multi-Probiotic® or iFlora™ 4-Kids Powder.
