Understanding the Funding Sources

- Ryan White Part B Base
- ADAP Supplemental
- Ryan White Supplemental
- ADAP Emergency Relief Fund
- Rebates
- State Funds



Conditions Resulting in Reduced Availability of Funds

- 15% (\$400,000 monthly) increase in ADAP/HIAP Expenses from 2018-2020
- 15% reduction in state funding due to COVID-19
- Changes in RW Supplemental Funding:
 - 2017/2018: \$26 Million
 - 2018/2019: \$11.5 Million
 - 2019/2020: \$4.9 Million
 - 2020/2021: Unknown



How Were Decisions Made?

- Prioritized fully funding ADAP/HIAP
- Examined previous funding utilization
- Considered other available community resources
- Accounted for current case loads and changes that have occurred
- Relied on expert review of proposals



Other Considerations

- Preventing ADAP/HIAP waiting lists
- Reviewed program outcomes and costs per client served
- Opportunities for strategic partnerships exist to improve utilization of programs
- Allowing agencies to determine where to prioritize services to serve their clients



What is Next?

- Final award determination for RW Supplemental funds is expected in the next 6-8 weeks
- Examining cost savings opportunities in the medical services program
- Working with SBA to demonstrate the relationship between expenses and rebates
- Available to have one-on-one meetings with care sites to help determine collaboration and efficiency alternatives
- Potential changes to award amounts
