Training Program Renewal Reminder

Each training program should receive a reminder from IDOH, via email, approximately one month prior to that program's renewal date. Even if this reminder is not received, the program director is still responsible for making sure an application for renewal is submitted to IDOHLTCTrainingprograms@health.in.gov prior to the renewal date and that approval is granted via an email response.

NAT programs must renew by April 1, and QMAT programs must renew by Oct. 1 every other year.

The program renewal dates are located at the top of the program's data sheet:

QMAT Application: 10/03/2016 QMAT Approved: 10/13/2016

Please confirm your renewal date and mark it on your calendar. If a program is expired for more than 90 days, the entire program approval process will again have to be completed. A lapse in approval dates for training programs can cause many issues for students and the program.
