#### **Over-the-Counter Naloxone Access**

Last month, Food and Drug Administration (FDA) advisors unanimously voted in favor of making Narcan available without a prescription. In several states, Narcan, otherwise known as naloxone, is already readily available. On the other hand, some states still have regulatory statutes that make naloxone difficult for the general population to access. Take for example Alabama, which only permits pharmacists and licensed physicians to distribute naloxone.

If naloxone is approved for over-the-counter use, access will improve nationwide. "For the sake of the public and saving lives, I believe this medication should be available over the counter to the public as soon as possible", said Dr. Katalin Roth, professor at George Washington University School of Medicine and Health Sciences. Advocates also hope that FDA approval for nonprescription naloxone will pave the way for more access to cheaper, more generic alternatives. Advisory panels convened in February to discuss approval for another naloxone spray, RiVive. Overall, the FDA is working to improve naloxone accessibility, and a final decision about nonprescription Narcan will be released by the end of March.

#### **Indiana Legislation Aimed at Reducing Overdose Deaths**

According to data from Indiana Department of Health, overdoses in Indiana reached record highs in 2020 and 2021. To address these trends, policymakers have been authoring legislation aimed at preventing drug overdose and strengthening the crisis response system in the state. One such bill is <a href="HB 1462">HB 1462</a> authored by Representative Ann Vermillion of Marion County. HB 1462 would require all emergency departments in the state to provide Indiana Department of Health an implementation plan for when patients have a substance-use related emergency.

At the bill's hearing, Mental Health America of Indiana's Vice President Brandon George said that there are discrepancies in emergency departments across the state that result in poor health outcomes for individuals with substance use disorder. HB 1462 would allow emergency departments to create individualized plans based on the resources they have and the populations they serve. Vermillion notes that HB 1462 connects to Senate Bill 1, which proposes expansions to mental healthcare across Indiana. The House approved HB 1462, and it has headed to the Senate Appropriations Committee.

### **Lifeline for Loss Support Group**


