## Senate Bill 1 Updates

Senate Bill 1 continues to make its way through the General Assembly. Authored by Sen. Michael Crider, the bill proposes expansions to mental health services in Indiana. Many Hoosiers and lawmakers alike shared personal testimonies about mental health and addiction, noting that the current system is outdated and ineffective. In fact, an Indiana Behavioral Health Commission report estimates that untreated mental illness costs Indiana \$4.2 billion annually.

The House Public Health committee unanimously passed the bill earlier this month. It has strong bipartisan support, but the next step is allocating funding for the mental health services proposed in the bill. Under Senate Bill 1, a 24/7 suicide crisis hotline would be established in addition to mobile crisis teams that are designed to respond to respond to mental health incidents. Supporters say they will continue to advocate for the bill as the budget is drafted. Looking forward, Senate Bill 1 heads to the House Ways and Means committee for approval.

### **Proposed Mandates for Xylazine Testing**

Indiana coroners are set to begin testing opioid overdose victims for xylazine under House Bill <u>1286.</u> Authored by Representative Jennifer Meltzer, the bill mandates toxicology screenings if the coroner reasonably suspects the cause of a person's death to be accidental or intentional opioid overdose.

Xylazine is a sedative used in veterinary medicine. According to the U.S. FDA, xylazine and fentanyl mixtures have been identified in 48 of 50 states, including Indiana. It is infiltrating illicit drug supplies across the nation and is not safe for human use. As xylazine is an increasing public health threat in Indiana, public health officials and law enforcement are taking measures to collect data about exposure.

Abbi Raben, a representative from the Indiana Coroners Association, notes that a majority of coroners already test for xylazine. Thus, House Bill 1286 would not incur a significant costs or administrative burdens. "The coroners fully support this legislation," she said. House Bill 1286 is headed to Gov. Eric Holcomb to be signed into law.

#### **De-escalation Training**



De-escalating a mental health crisis is a very difficult skill set and starts with the worker calming themselves and maintaining their composure as they move toward the situation. Fear elicits a threat response in both the upset person and the one trying to help. This means that without specific strategies it is common for the worker to inadvertently worsen the situation as they react to the "noise" of the situation. This training will equip learners with skills to reground themselves in stressful situations.
