Roll Call: Present were Jasper Fogleman, Valerie Runion, Ed Moyer, and Dale Cushman, and Terry Hardin.

Visitors present: Troy Stewart, Terry Runion, Jim Webber, Donna Wheeldon, an unknown visitor, Bonnie Morton and Candy Peach.

Jasper Fogleman opened the meeting with the reading of law IC 23-14-67.

By-laws were introduced, voted on unanimously, and signed.

Mail Call:

1. Chairman requested that a letter of thanks be sent to the American Legion for the use of the hall.
2. Chairman read a letter addressed to the FCCC from DNR.
3. Chairman read a letter addressed to the FCCC from the Indiana Historical Society.

Chairman gave a list of each cemetery, divided by township, to each Trustee present.

OLD BUSINESS:

1. There is no old business as this is the first meeting of the FCCC.

NEW BUSINESS:

1. Troy Township:
 - a. Poor Farm Cemetery-Stones and graves washed out by creek. Jasper Fogleman currently looking for volunteers.
 - b. DeHaven Cemetery-No report
2. Van Buren Township:
 - a. Birch Cemetery has been located. No stones remain. Word of mouth claims that there were possibly 10-15 stones at one time.
3. Davis Township:
 - a. Maysville Cemetery-No report
4. Cain Township:
 - a. Old Town Cemetery- Cain Wildcats 4-H Club to head up the cleaning project. First step is to get it surveyed. They are currently looking at sources for survey. Stones lay in creek at bottom of 70 ft. ravine. Stones

have been used as steps leading down the ravine. After survey they will start tree removal.

5. Jackson Township:

- a. Jackville Cemetery-Boy Scout Troop will help clean up and restore cemetery. Corner posts to be reset and fence to be re-strung.

6. Shawnee Township:

- a. Rob Roy Cemetery-Tree removal to be done.

Walt Wilson has official copy of Fountain County Cemeteries Plat Map. This map is to be completed and turned in to the Assessor's Office by January 1, 2010.

Motion made by Jasper Fogleman to change FCCC meetings to the first Thursday of every month at 6:00 pm. Place to be determined at a later date. Motion seconded by Dale Cushman. Vote unanimous. By-laws will be changed to reflect this decision.
