ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

RACES 1 & 4: Weight corrections – Apprentice jockey German Terraza is a 5 lb. apprentice, not 7 lb.

RACE 1: HISA riding crop violation – German Terraza committed a class 3 violation of HISA rule 2280(B)(1) by striking his horse 7 times with the crop. \$250 fine, one-day suspension.

RACE 4: Ownership correction - #8 ZACH: Haran Thoroughbreds (John Haran).

RACE 4: Jockey objection – Claim of foul from Hannah Leahey (#1 MAMA'S BOY, 5th place) alleging interference by #6 ANDELE ANDELE (Abel Cedillo, 4th place) and #8 ZACH (Evin Roman, 6th place). After reviewing video replay, the Stewards disallowed the claim of foul because the horse that was responsible (ZACH) for the incident finished behind the horse that was bothered (MAMA'S BOY); ANDELE ANDELE was held blameless. No action was taken.


RACE 6: Program correction - #11 SMACKDOWN is a gelding; #5 FULL ARMOR is a gelding (FTG).

RACE 7: Program correction - #8 FIVE O' SOMEWHERE does not race with Lasix.

RACE 8: HISA riding crop violations – Augustin Gomez (#8 LOBO SALVAJE) and Rogelio Miranda (#3 BEKHAMBOY) committed class 3 violations of HISA 2280(B)(1) by striking their mounts seven times. \$250, 1-day suspension.

RACE 9: Inquiry – to review action in the early stages of the race during which #6 CRUISINDOWNTHEBEACH was shut off between horses soon after leaving the gate. After reviewing video replay the Stewards declined to take action because there was no conclusive evidence that the action altered the final placings.
