Indiana Thoroughbred Breed Development Advisory Committee November 22, 2021 Meeting Minutes

- I Call to Order & Opening Remarks 1 pm
- II Minutes September 9, 2021 Blaine made a motion to approve, Tianna seconded, motion passed unanimously.
- III Mare Residency Rule Consideration
 - a. Draft Rule
 - b. Mare Residency Guidelines

Jessica presented the proposed mare residency rule change. She said that the best way to do it is to give the Director of Breed Development the ability to leave early. The director may approve this request and request shall be in writing with, at least, 5 days notice. This item would go to the December Commission meeting and would require a rule change if approved by the Committee. Staff will create a form for these requests.

The proposal was discussed. ITOBA would like to see this addressed next year. Tom Mosley asked how did we foal out 2 times as many mares in the past? We need to look at the entire inspection process/program. It's too late in the year for changes this year. ITOBA would like to see entire residency issue examined next year.

Janice explained that her facility is full. Years ago there were 3 major farms the only way to squeeze more in is to turn them around faster. Bruce said that the mares will get bred back to IN Stallions. Tianna asked if the committee could grant waivers. Jessica explained that only the executive director can waive a rule. Jay stated that it gives us less incentive to keep mares in the state year-round. Bruce asked if it would increase mare numbers. Jay said he didn't know. Tom Mosley said that we need outside mares for numbers. Janice explained that the more horses she can foal out, the more mares she can breed to her new stallion. Mike Lauer stated that we are making a mountain out of a molehill, this is a small plus that won't matter much. Tom Mosley asked if farms down south were full, wouldn't they find a farm farther north. Janice explained that Indiana Stallion Station is also full.

Bruce called for any more comments. Committee members discussed the proposal.

Blaine made a motion to approve the mare residency rule change and guidelines. Bruce seconded. Motion passed unanimously.

IV Proposed Stallion Registration Rule Changes

The proposed Indiana Sire rule change was discussed. It was asked if a stallion that applies for registration after covering mares be registered retroactively?

Any stallion that covers any mares outside of IN cannot be registered.

Blaine made a motion to approve with a \$250/mare bred penalty and a \$1,000 minimum penalty. Tianna seconded. Motion passed unanimously.

V. Review of 2021 Racing Program

Bruce noted that 2021 has been a great year and great program for Indiana.

Jessica presented the Race Summary Report. In 2021, we had 400 restricted races, total of 258 IN Bred and 142 IN Sired. Base Purse has ranged from \$9,000 and \$25,0000. Indiana Grand put more than original commitment, contributing over \$5.9 million to purses. The average base purse was \$14,795. In looking at the entire program the total to be spent from Breed Development: \$14,292,592, resulting in over 21 million (does not include races between 10K) or open race supplement, about \$450,000 to be paid out the Indiana Breed Development Program in 2021.

Tiana asked if this year has been a fluke? Jessica is looking at revenue projections for next year. We should end up with 2.6 million in reserves. The commission expects us to keep 2 million in reserves. We will have \$600,000 to use looking at adjusted gross revenue: average gives us 13.1 million dollars for Thoroughbreds.

Jessica explained that the second-place awards will be lower than 2.6%. Blaine would like to see a guaranteed percentage for second-place in the future.

Average overnight purse was \$33,088 for \$10k claiming races and up. The average cost to TB Breed Development Program for purses was \$27,418, and \$42,215 if you consider awards associated with each race.

Blaine asked if we will be paying 3rd place breeder and stallion awards. Jessica noted that at this time funding was not available to do so unless we cut something else.

It was noted that the expansion of the casino will be completed January 1 and the last payment mandated by the final order is next year.

VI. Preliminary Discussion Regarding 2022 Program

The program for 2022 was discussed, noting that a meeting would be scheduled at a later date. Additionally, during the December IHRC meeting, Jessica will request for the Commission to delegate to the Executive Director the ability to approve the Thoroughbred Breed Development Program for 2022.
