


RACE 8: Ownership correction - #9 GOSPEL MUSIC: the principal of Sienna Farm LLC is Todd Manganaro.

HIWU's testing program includes the testing of selected horses after routine times workouts/breezes (Post-Work). This testing is separate from Vet's List testing. Trainers will be notified of selection for Post-Work testing within one hour of a horse's completion of the breeze. It is against HISA rules to breeze a horse within 7-days of an intra-articular injection. If you inject a horse on Saturday, you cannot breeze the horse until the following Saturday.

House Rule: Recency Requirements for Horseshoe Indianapolis | This House Rule will supersede IHRC Regulation 71 IAC 7.5-4-1 as it applies specifically to a horse that has not started for a period of two hundred & forty (240) days or more. A horse that has not started in the previous 240 days is not eligible to start at Horseshoe Indianapolis until it has successfully completed a racing soundness examination administered by the Regulatory or Track Veterinarian. If the Regulatory or Track Veterinarian conducting the racing soundness examination finds the results of the examination to be unsatisfactory or inconclusive as to the racing soundness of the horse, the Veterinarian may, at his/her sole discretion, place the horse on the Veterinarian's List & establish conditions for removal from the list including, but not limited to, laboratory testing of biological samples & an official workout of a specified distance completed within a specified minimum time.

ATTENTION TRAINERS: Please make certain you, your owners & your employees have completed the Indiana Horse Racing Commission licensing process for 2023. In addition, please be aware that the entire ownership for
