Please consider this letter as Centaur Acquisition, LLC's (Grand) Application for Annual Permit Renewal and for approval of 2018 Race Dates.

This application is made pursuant to IC 4.31-5-2(a) and IC 4-31-5-9 as well as the following administrative rules: (1) 71 IAC 11-1-3(b); (2) 71 IAC 11-1-7; (3) 71 IAC 11-1-21 and (4) 71 IAC 2-9-1. In support thereof Grand states that:

1) Grand is an Indiana limited liability company;
2) Grand is the holder of a recognized meeting permit to conduct pari-mutuel horse racing at Grand, 4200 N. Michigan Road, Shelbyville, Indiana 46176 and that the Indiana Horse Racing Commission (Commission) has previously approved Grand for the exclusive racing of Quarter Horse and Thoroughbred horses;
3) Grand is the owner of its racing plant with a physically connected clubhouse that displays for public inspection trophies, memorabilia and instructional materials depicting the history of horse racing and is available as a repository for the collections of the Indiana Harness Horse Hall of Fame; and
4) Grand proposes to conduct a total of 120 days of Thoroughbred and Quarter Horse racing, commencing on April 17, 2018, and concluding on November 7, 2018.


Of the 120 race days, which are required by IC 4-31-7-7 if Grand is to enjoy unlimited simulcasting, 114 days will be devoted to Thoroughbred racing with occasional Quarter Horse racing and 6 days will be devoted exclusively to Quarter Horse contests. Racing will take place Tuesday, Wednesday, Friday and Saturday, as well as the following two Thursdays: July 19 and September 6. A calendar of race dates is attached hereto as Exhibit $A$ and by reference made a part hereof.

Enclosed please find Grand's check in the amount of $\$ 5,000.00$ made payable to the Commission in payment of the annual non-refundable renewal fee and ten (10) copies of this letter. Please return a file stamped copy of this letter in the self-addressed, post paid envelope enclosed.
