Statutory Mandate of Funds Allocated to Sired Program

There was a legislative change to the statute made during the 2019 session which mandates a minimum of 41% be allocated to the Sired portion of the program. House Enrolled Act No. 1196 states that of the funds allocated to the Thoroughbred Breed Development Fund that...

"...at least forty-one (41%) to the Indiana sired horses program."

Due to funding the proposed program allocates approximately 40 % of the Breed Development Funds to the sired program, the IHRC staff will work with the racing office throughout the year to ensure that the 41% mandate is achieved.

Summary of the 2021 Proposed Program

- ✓ **Stakes Program** Due to reduced funding, and in order to not eliminate any stakes races, the purses for all Breed Development Stake Races are to be contested at the same reduced level as they were for 2020.
- ✓ Continuation of an "Indiana Breeders Day" & "Indiana Stallion Day" we will work with racetrack management to continue this day to help showcase our Thoroughbred Breed Development Program.
- ✓ Purse separation between Bred and Sired races Purses for 2021 will be contested at the same level they were for 2020. This includes purses for Indiana Sired races being above those of Indiana Bred races. With the statutory mandate, this assists the program in reaching the 41% requirement, as well as encourages growth in our program.
- ✓ **Breeder's Awards and Stallion Owner Awards** This program will remain as it did in 2020, with awards being paid to 1st Place Finishers in eligible races. The addition of 2nd place and 3rd place awards are a priority to this Committee, however reduced revenues made it impossible to implement new elements to the program during this pandemic recovery period.

Proposed Program and Guidelines

Scheduled Overnight Races:

There are 312 proposed scheduled races, with 118 races for Indiana sired horses and 194 races for Indiana bred horses. Funds allocated for regularly scheduled races that do not fill may be added to the Discretionary Race Fund throughout the meet for the racing secretary to utilize to split races and bring back at another time.

Discretionary Race Fund:

In the past we have only scheduled out a portion of the races and included the remaining funds in a "Discretionary Race Fund". In order to more accurately budget the program and give a clearer picture and ensure we are attempting to meet the statutory mandate of 41%, the program in its entirety has been provided. The racing secretary will still have discretion when races do not fill or splitting races as long as the overall budgets are adhered to and program goals (% to sired) are met. IHRC staff will work closely with the racing secretary throughout the meet, to ensure these goals are achieved.

Signature Stake Races:

The Signature Stake races will continue as they did in 2020, with an additional two Signature Stakes for Sired horses. Due to reduced revenue, the purses for these stake races remain unchanged and will be contested at the same level as 2020, except they will be added money events.

Remaining Stakes Program:

The purses for these races will be raced at \$75,000, which allows for the stake program to remain intact. We will be working with the racetrack to update some of the names of the Stake races, and eliminate nomination fees to allow greater participation.

Preference for all stake races will be high weights preferred, second preference lifetime earnings.

In addition, Breed Development will continue to contribute funding to the ITOBA Stallion Stakes. Breed Development will contribute \$15,000 to each race (for a total expenditure of \$30,000).

General Program Guidelines:

- Each regularly scheduled overnight race that fills with **seven** (7) or more betting interests will be carded. It is the discretion of the racing secretary as whether to utilize races with fewer than **seven** (7) betting interests.
- Stake races are not required to have eight (8) starters to be used.
- If a regularly scheduled race fails to be carded due to a lack of eight (8) betting interests, but contains at least six (6) preferred betting interests, the racing secretary shall bring that race back the following day. Should the race not fill with eight (8) betting interests again, the purse money from that race will be allocated to the Discretionary Race Fund.
- In order for a race to be split, it must contain at least eight (8) betting interests in each.
- The racing secretary has the discretion to write Indiana-bred claiming races at a level below \$10,000 as needed. These races will not be used to replace any race in the Thoroughbred Breed Development Program.
- All stakes shall be "added money" with the nomination, entry and starting fees contributing to the purse as indicated in 71 IAC 1.5-1-97.
- One-third of all allowance races, including maiden special weights, are to be written for Indiana sired horses. The racing secretary shall make every attempt to write Indiana-sired races in advance of Indiana-bred races for the same condition. In addition, the Committee encourages the racing secretary to increase the number of Sired races in excess of this guideline as needed.
- The racing secretary shall make every attempt to provide 50% racing opportunities for colts and geldings and 50% for fillies and mares in the overnight program.
- The racing secretary shall make every attempt to write at least 30% of all maiden and allowance races going long.
- Recognizing the importance of turf racing for Indiana Bred/Sired horses, the racing secretary shall make every attempt to write an appropriate number of turf races.

Indiana –Bred Preference:

Allowance and Maiden Special Weight

Preference will be given to horses that have not started for less than \$10,000 in their last five starts. A horse can regain preference by running 1st, 2nd or 3rd for \$10,000 or more since last starting for less than \$10,000.

Indiana – Bred Maiden Eligibility:

Horses that have not finished 5th or better in one of their last **six** starts are **least preferred** for Maiden Special Weight Races.

Limited Preferred Starter Status for Indiana-Breds in Open Company Races (Stakes Excluded):

Once a registered Indiana-bred receives an R Date or E Date, it will receive Starter Preferences over Non Indiana-bred horses that have equal R Dates or E Dates. Indiana-breds will NOT receive starter preference over Non Indiana-breds with better R Dates, E Dates or when both horses have 0 dates. Preference dates will not supersede conditions of a race.

Exclusion of Indiana - Bred Wins in Open Other Than Conditioned Allowance Races

The Racing Secretary has agreed to include the words "Indiana-bred Race" in all other than open Allowances.

Examples:

- (1) Non winners of a race other than Maiden, Claiming or Indiana-bred race.
- (2) Non winners of two races other than Maiden, Claiming or Indiana-bred race.
- (3) Non winners of three races other than Maiden, Claiming or Indiana-bred race.

Indiana- Bred Weight Allowance:

Registered Indiana-breds shall automatically receive a 3 lb. weight allowance when competing in races not restricted to Indiana-breds. Stakes races will be exempt from this requirement.

Indiana – Sired Weight Allowance in Indiana Bred Races:

In Indiana restricted races, registered Indiana – sired horses shall receive a weight allowance of 3 lbs. when running less than seven and one-half furlongs (7 $\frac{1}{2}$) and 5 lbs. when running seven and one-half furlongs or greater.

The 2021 Program

- ✓ Breed Development Fund to pay 25% of the purse for stakes races and trials (prior to any added monies).
- ✓ Trial purses to remain at \$15,000 per trial.
- ✓ Breed Development Fund to pay 20% of the purse for overnight races, increase purse levels of overnight races by \$2,000 each.
- ✓ Owner, Breeder and Stallion Owner Awards in all races will be paid at 12.5%. The awards for Open Stake races were paid at 6.25% during 2021.
- ✓ Scheduling of 74 Overnight races.
- ✓ There will not be trials for the Hoosier Classic and Born Runner stakes for older horses (4 YR Olds & UP). The Bob Woodard will continue to have trials if there are 14 or more entries. Entry will be determined by 2020/2021 earnings.
- ✓ Each regularly scheduled overnight race that fills with eight (8) or more betting interests will be carded. It is the discretion of the racing secretary as to whether to utilize races with fewer than eight (8) betting interests.

Indiana Sires Stakes

Significant changes were made to the structure of the Indiana Sires Stakes program for 2019, and the new structure worked well. We would like to continue with this structure, only making minor improvements which had been approved to implement in 2020, however had to be adjusted due to Covid-19 budget restraints. The 2021 Indiana Sires Stakes Program will feature:

- Six legs for 2-Year-Olds leading up to a \$250,000 Super Final
- Eight legs for 3-Year-Olds leading up to a \$250,000 Super Final
- Super Final Participants finishing 6th through 10th will receive a \$4,000 purse payout each for earning their way into Super Finals
- Addition of \$25,000 consolations for all two and three year old categories
- Budgeting in \$100,000 for rounding of legs and boosting of purses in legs with 11 starters. Even though the purse amounts are fixed, we did not include a contingency for this in the 2019 program. We are including \$100,000 to account for these occurrences.

Funding for the program will be structured as follows:

- Nomination fees will be retained by the Breed Development Fund. Nomination fees will remain at \$500.
- Entry fee for each leg will be \$500.
- There will not be an entry fee required for the Super Final.
- ➤ Breed Development will fund the purse, \$250,000 for the Super Final (for top ten horses from Leg Finals) plus the \$4,000 each 6th through 10th place finisher will receive. For a total payout of \$270,000.
- ➤ In legs with a field of 11 starters, an additional 6% of the purse will be paid with 3% to the sixth place finisher, 2% to the seventh place finisher, 1% to the eighth place finisher.
- ➤ Hoosier Park agrees to write overnight races for Sires Stakes eligible horses to provide additional racing opportunities. These races will run concurrent with the Sires Stakes program. Breed Development will earmark a minimum of \$500,000 from the funds allocated for IS Overnight/Mini Series Budget.

Indiana Sired Fair Circuit

The fair program continues to be an important part of the Indiana program. In reviewing the program for 2020, the program will remain the same with minor improvements we had approved to implement in 2020, but did not due to Covid-19 budget constraints. They are:

- Increase purses for the Championship Races at the Indiana State Fair from \$20,000 to \$25,000 and Consolation races from \$8,000 to \$10,000.
- Lower \$ earnings cap on Series 2 to NW \$10,000 up to completion of Series 1.

The structure of the 2021 program is as follows:

• Pay \$500 to each $6^{th} - 8^{th}$ place finisher in the Series 1 Championship races

 Approximately 23 racing programs to be held (including ISA Elite Program & Championships).

Series 1:

- Purses \$3,000 Division
- Championship \$25,000
- Consolation **\$10,000**

Series 2:

- for NW **\$10,000** in 2021 up to and including 8/15/21.
- Purses \$3,000 Division
- Championship \$10,000

ISA Elite – Breed Development will continue to support this event. ISA Elite Races to be funded at \$7,000 per category as follows. Breeder's Awards

Continue the current format from 2013.

- Total Payout for Breeder's Awards \$700,000
- A horse must win an eligible race to be eligible to the Breeder's Award Pool. The criteria is as follows:
 - o Two & Three Year Olds ISB (Indiana Sired & Bred) Horses only that win any race at the Pari-Mutuel Track in Indiana or ISFC (Indiana Sired Fair Circuit) Championship Races excluding any race in which the horse is entered for a claiming price.

- o Four Eleven Year Olds ISB Horses that win:
 - Final of any Breed Development Indiana Sired Late Closer Event
 - Elimination or Final of the Indiana Sires Stakes
 - Track's Open or Invitational Race
 - Excluding any race in which the horse is entered for a claiming price.
- o Aged Horses (12 years old & older) IS Horses that win:
 - Final of any Breed Development Indiana Sired Late Closer Event
 - Elimination or Final of the Indiana Sires Stakes
 - Track's Open or Invitational Race
 - Excluding any race in which the horse is entered for a claiming price.
- Awards will be distributed to eligible breeder's based on the percentage of win earnings of the
 total win earnings available. Please see the example provided below. Note that it includes only a

 responsible for funding any remaining races.
- Hoosier Park agrees to write overnight races for Sires Stakes eligible horses to provide additional racing opportunities. These races will run concurrent with the Sires Stakes program. Breed Development will earmark a minimum of \$500,000 from these funds for this purpose.

Indiana Sired Late Closers

- Total BDF Payout for Indiana Sired Late Closers \$250,000
- Purse Account contribution to remain at \$4,000 per leg
- Some Late Closers have been eliminated, however the track intends to provide opportunities in the form of Mini Series/Overnight Series.

Chairman Borst and Executive Director Pitman,

At the December 10, 2020 meeting of the Indiana Horse Racing Commission the 2021 dates for Indiana Grand were unanimously approved. We appreciate that and look forward to the start of our season on April 13, 2021.

One of the days that was approved, however, was Kentucky Derby day, May 1, 2021. This date was originally considered as a strong possibility for a "return to normalcy" by our staff. The plans were to make a big splash and celebrate with our horsemen and patrons for overcoming a difficult 2020 season as well as looking forward to numerous fun initiatives for our on-track customers during the coming meet. But as we've gotten close to February our staff is very concerned that we cannot guarantee a normal experience by May 1st and that running live racing, with a potentially large crowd, may not be the safest or wisest decision on that day.

I've spoken to Joe Davis and Paul Martin and they agree with our concerns. With that in mind Indiana Grand respectfully, and with the support of our horsemen, requests moving the assigned live racing day on Saturday, May 1, 2021 to Monday, November 8, 2021. With this request there would be no net change in the number of assigned days.

The main issue with the timeliness of this request is that we are a few weeks away from publishing our first condition book. May 1st is currently scheduled to be a part of that condition book but in a perfect world, if you should approve this dates change request, we would omit that day from what goes to print.
