



Race 10 – General inquiry posted looking at two separate incidents in the race. The first area of concern was the start. No. 10 AUTOMATIC ANDY (Mike Peterson) broke a hobble and did not finish. After reviewing video the judges determined that the broke equipment occurred after the start and therefore No. 10 AUTOMATIC ANDY was a starter for wagering purposes.

The second general inquiry involved unofficial fifth place finisher No. 1 ELEANOR'S KNIGHT (Kiwon Waldron) for possible interference while on a break before and after the quarter in the first turn. While off stride No. 1 interfered with multiple trailing horses. For interference while on a break No. 1 ELEANOR'S KNIGHT finished fifth placed ninth.

No. 1 ELEANOR'S KNIGHT was also reported as a gelding.
