## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 4 – Inquiry posted on unofficial fourth place finisher No. 5 BELIKETHIS (John DeLong) for possible violation of the breaking rule before the start. Video confirmed that Mr. DeLong complied with all aspects of the breaking rule and the horse was placed as finished.

Race 6 - Track downgraded from "fast" to "sloppy".

Race 12 – Inquiry posted on unofficial race winner No. 1 TELLMEITMATTERS for possible interference to unofficial fifth place finisher No. 8 MARTZ TELLY (Dexter Dunn) entering the backstretch just past the quarter. After reviewing video and speaking with driver Dunn that judges determined that DeLong had already started out to follow No. 3 NOBLESVILLE and that No. 8 MARTZ TELLY was three-wide after getting rough. No violation occurred and all horses were placed as originally finished.

Race 13 – Trace Tetrick, driver of No. 8 COACH STEFANOS, fined \$200.00 for foot out of the stirrup making contact with the horse.

General inquiry posted looking at a breaking horse, No. 1 BUZZSAW RUSS (John DeLong), for possible violation of the breaking rule in the stretch. The judges determined that driver DeLong complied with all aspects of the breaking rule and the horse was not lapped on by other horses at the finish. No reason for disqualification and the horse was placed as finished.
